**Subject:- Information regarding purchase of new motor vehicle.**

In reference to the aforementioned subject, it is most respectfully submitted that the undersigned is presently posted as ADJ-02/Special Judge Gangster Act, Etah w.e.f. 16.04.2024.

The undersigned has purchased new motor vehicle Jeep Compass 2024 on May 29, 2024 bearing **Chassis No.-**MCANJPCY7RFB08136\*4R and **Engine No.-**4311749 from Jeep Landmark Lifestyles Cars Pvt. Ltd Delhi. The total amount paid towards purchasing the motor vehicle is Rs. 28,64,927/- with respect to which an amount of Rs.9,90,000/- was paid through bank transfer and a car loan for Rs.18,00,000/- was availed from State Bank of India. Regarding the amount paid by the undersigned for purchasing the vehicle, an amount of Rs. 5,95,000/- was paid from the bank account of the undersigned and Rs. 4,00,000/- was paid from the bank account of my wife. The bank statement with respect to these transactions have been enclosed herewith.



The undersigned has also exchanged his old car (Skoda Fabia UP16AH0851) with the dealer (Jeep Landmark Lifestyles Cars Pvt. Ltd Delhi), whose value was assessed by the dealer as Rs.90,000/-. The value of the old car was adjusted by the dealer in the final bill of the new car purchased along with an exchange bonus of Rs.25,000/- which was offered on behalf of the company Jeep India. The delivery note issued by the dealer has been enclosed herewith.


