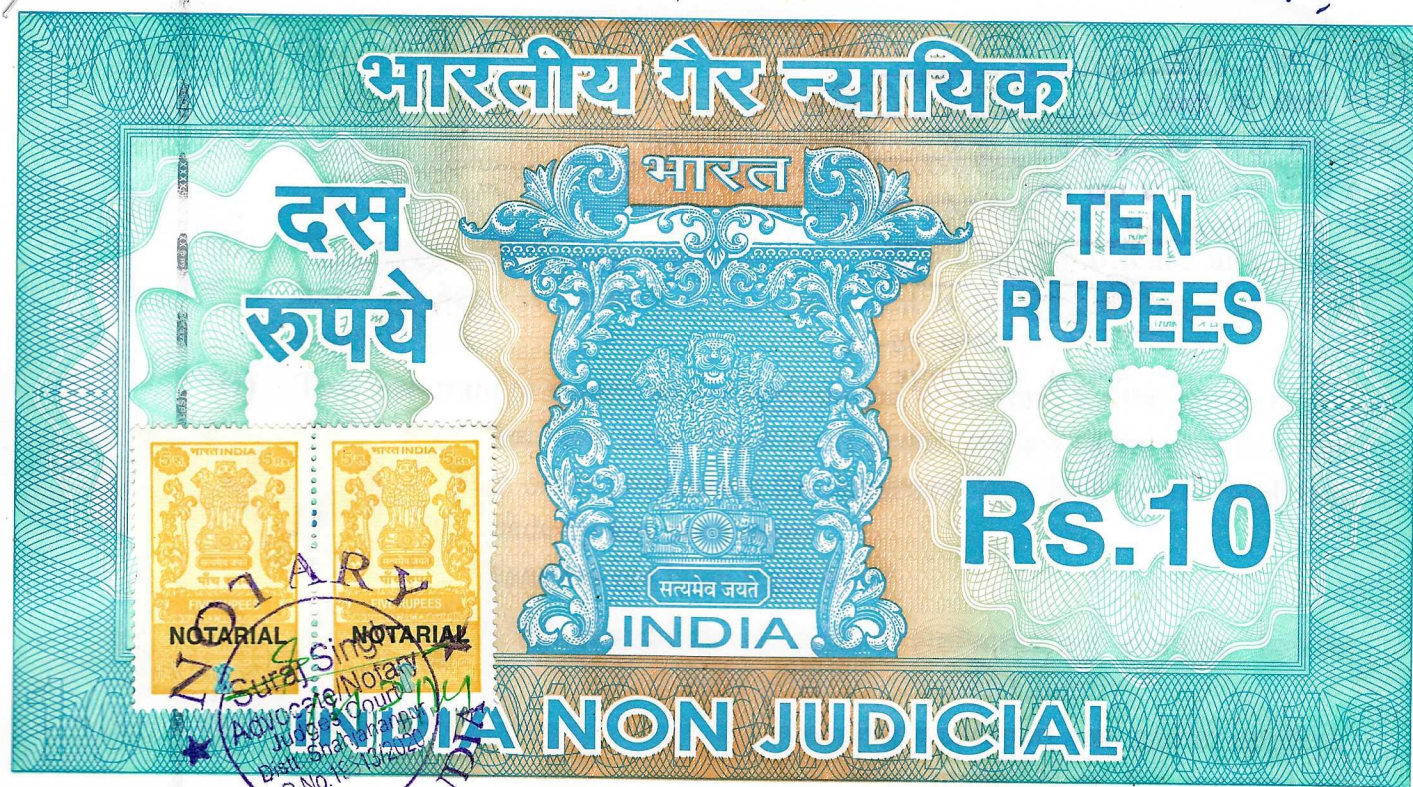

court in India for any offence involving moral turpitude and sentenced in respect thereof to imprisonment for not less than two years.

- (G) That the proceeding in respect of any offence of any offence alleged to have not been committed by the applicant is pending before a criminal court in India.
- (H) That a warrant or summons for appearance, or warrant for the arrest, of the applicant has not been issued by a court under any law of the time being in force or that an order prohibiting the departure from India of the applicant has not been made by any such court.
