Subject- Regarding giving the option of Old Pension Scheme in the compliance of letter No. 9691/IV-F-82(Pension)/Admin. (A) Section Dated: 16.07.2024 issued by the Hon'ble High Court Allahabad in the light of G.O. No. 14/2024/Sa-3-243/X-2024/301(1)/2024 dated 28.06.2024 read with G.O. No.- 20/2024/Sa-3-276/X-2024/301(1)/2024 dated 11.07.2024

Sir,

It is most respectfully submitted that in compliance with the letter No. 9691/IV-F-82(Pension)/Admin. (A) Section Dated: 16.07.2024 issued by the Hon'ble High Court Allahabad and the Government Order issued by the Government of Uttar Pradesh No. 20/2024/Sa-3-276/X-2024/301(1)/2024 dated 11.07.2024 in the light of Government Order No. 14/2024/S-3-243/X-2024/301(1)/2024, dated 28.06.2024, whereby the facility to opt Old Pension Scheme has been given to all such U.P. Government employees covered under National Pension System, who have been selected against such posts/vacancies, which were advertised before the State Government notification No. Sa-3-379/X-2005-301(9)-2003 dated 28.03.2005, pertaining to implementation of Defined Contribution Pension Scheme (National Pension System) in the State.

It is pertinent to mention here that the applicant was appointed as Civil Judge (Junior Division) in U.P. Nyayik Sewa on 26.05.2006 on the basis of the vacancy advertisement no. A-2/E-1/2003 dated 15.11.2003 and the date of joining in the aforesaid service was 16.06.2006. In light of the instructions given in the circular, the applicant is entitled to get full benefits of the Old Pension Scheme. The applicant chooses the option under the Old Pension Scheme and is entitled to get full benefits of the Old Pension Scheme under the U.P. Retirement Benefit Rules, 1961. The duly filled option form is here-with enclosed.

Therefore, it is humbly requested to the goodself to kindly accept the option of the Old Pension Scheme under the U.P. Retirement Benefit Rules, 1961 of the applicant.
