
Respected Sir,

Kindly consider your goodself letter No. 9691/IV-F-82(Pension)/Admin.(A) dated 16.07.2024 regarding above mentioned subject in reference to G.O. No.14/2024/Sa-3-243/X-2024/301(1)/2024 dated 28.06.2024 of the Government of U.P. whereby all such U.P. Government Employees who are covered under National Pension System/New Pension Scheme and have been appointed on the posts/vacancies that were advertised/published prior to issuance of State Government Notification No. Sa-3-379/X-2005-301(9)-2003 dated 28.03.2005, pertaining to implementation of National Pension System/New Pension Scheme, have been given the facility to opt Old Pension Scheme, to be covered under U.P. Retirement Benefits Rules, 1961 within the specified time limit of 31.10.2024.

In compliance of above said subject and letter, it is humbly submitted that the applicant has been appointed / selected advertisement / publication dated 15.11.2003, Advertisement No. A-02/E-01/2003, which was published in the employment news on dated 22-28, November 2003, U.P.
