
It is humbly submitted that I am applying for issuance of ordinary passport and hereby submitting prior information for the same.

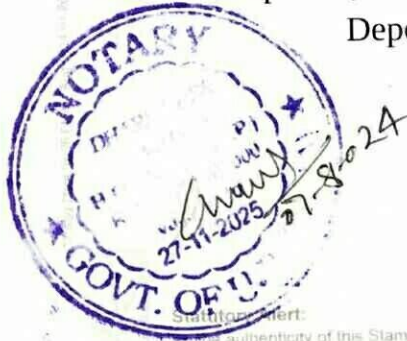




