
**AFFIDAVIT**

I, Sadhana Kumari Gupta W/o Saurabh Kumar Verma R/o Ward No. 11, Ichauna Purvi, Station Road, Salempur, Deoria (U.P.), present address T-4/2, A.D.M. Compound, Civil Lines, Bareilly, Presently posted as Additional Chief Judicial Magistrate-II, Bareilly do hereby solemnly affirm as under:-

1. That the deponent is a citizen of India.
2. That the deponent will not, or is not likely to engage outside India in activities prejudicial to the sovereignty and integrity of India.
3. That the departure of the deponent from India will not, or is not likely to, be detrimental to the security of India.

5. That the deponent has, at any time during the period of five years immediately preceding the date of his application, not being convicted by a court in India for any offence involving moral turpitudes and sentenced in respect thereof to imprisonment for not less than two years.

7. That a warrant or summons for the appearance, or warrant for the arrest, of the deponent has not been issued by a court under any law for the time being in force or that an order prohibiting the departure from India of the deponent has not been made by any such court.
8. That the deponent has not been repatriated.
9. That there is no possibility of arising embarrassing position before government of U.P. due to his visit to any foreign country.
10. That issue of identity certificate for obtaining a passport was never refused to him.
11. That he has not visited any foreign country.
