Sub Regarding exercise of one time option to switch from National Pension System/New Pension Scheme to Old Pension Scheme or to remain in New Pension Scheme in light of G.O. No. 14/2024/Sa-3-243/X-2024/301(1)/2024 dated 28.06.2024 read with G.O. No.20/2024/Sa-3-276/X-2024/301(1)/2024 dated 11.07.2024 of the Government of U.P.

Sir,

With reference to aforesaid subject, I am directed to invite your goodselves kind attention towards G.O. No. 4/2024/Sa-3-243/X-2024/301(1)/2024 dated 28.06.2024 of the Government of U.P. whereby all such U.P. Government Employees who are covered under National Pension System/New Pension Scheme and have been appointed on the posts/vacancies that were advertised/published prior to issuance of State Government Notification No. Sa-3-379/X-2005-301(9)-2003 dated 28.03.2005, pertaining to implementation of National Pension System/New Pension Scheme, have been given the facility to opt Old Pension Scheme, to be covered under U.P. Retirement Benefits Rules, 1961 within the specified time-limit of 31.10.2024.

In this regard, I am directed to say that all the Judicial Officers working under the kind control of the High Court of Judicature at Allahabad who have been appointed/selected in U.P. Nyayik Sewa/U.P.H.J.S against the vacancies advertised prior to issuance of Notification dated 28.03.2005, pertaining to implementation of National Pension System/New Pension Scheme, also come under the purview of aforesaid G.O. No. 4/2024/Sa-3-243/X-2024/301(1)/2024 dated 28.06.2024 of the Government of U.P.

Hence, applications are invited from all such Judicial Officers of the State of U.P. who fulfill the criteria as laid down in aforesaid G.O. dated 28.06.2024, within the specified admissible time-limit, mentioned therein. Also, as per the proforma of Option Form issued vide subsequent G.O. No. 20/2024/Sa-3-276/X-2024/301(1)/2024 dated 11.07.2024, it is evident that all such Judicial Officers who have been appointed in U.P. Nyayik Sewa/U.P.H.J.S against the vacancies advertised prior to issuance of State Government Notification No. Sa-3-379/X-2005-301(9)-2003 dated 28.03.2005, are required to fill the Option Form either they opt Old Pension Scheme under the provisions of aforesaid G.O. dated 28.06.2024 or choose to remain in National Pension System/New Pension Scheme.


