3. The applicant has travelled Tanzania 08.05.2019 to 03.06.2019 before joining the judicial services.

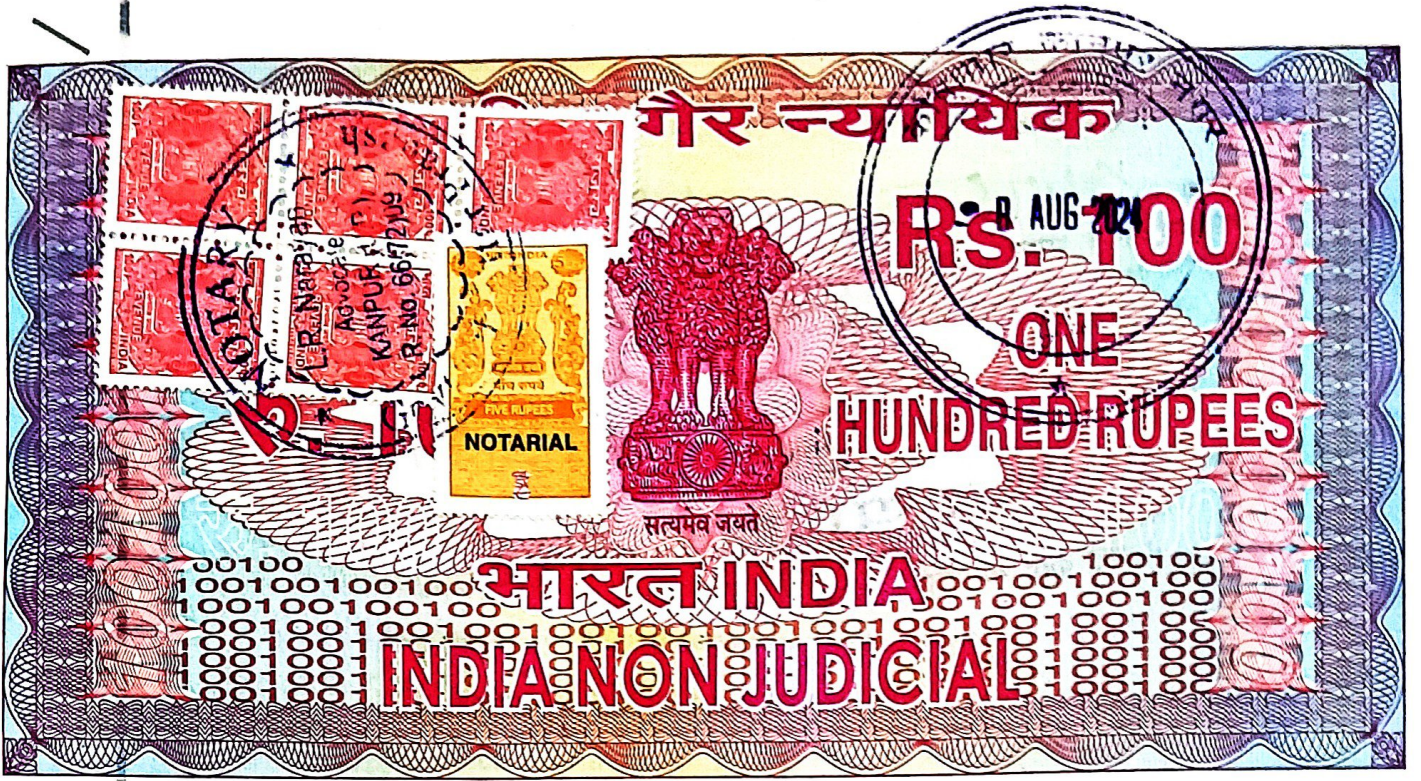

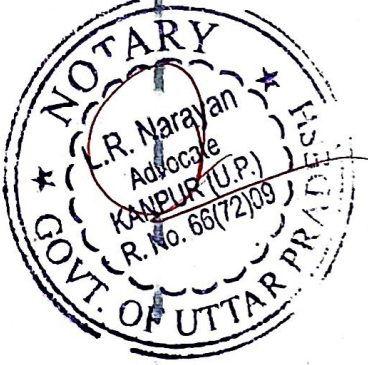

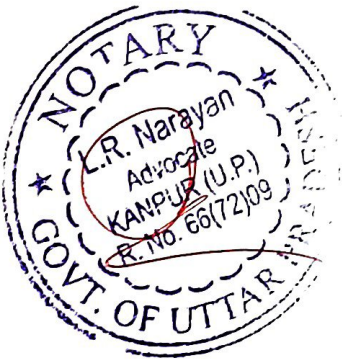
