AFFIDAVIT

2. that the applicant is a citizen of India;

7. that proceedings in respect of any offence alleged to have been committed by the applicant are not pending before a criminal court in India;

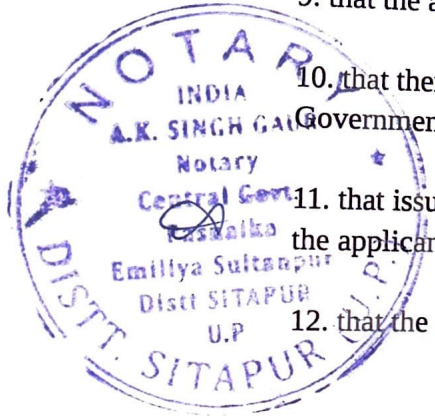

9. that the applicant has not been repatriated;

10. that there is no possibility of an embarrassing position arising before the Government of Uttar Pradesh due to the applicant's visit to any foreign country;

11. that issue of "Identity Certificate" for obtaining a passport was never refused to the applicant;

12. that the applicant has never visited any foreign country earlier.
