

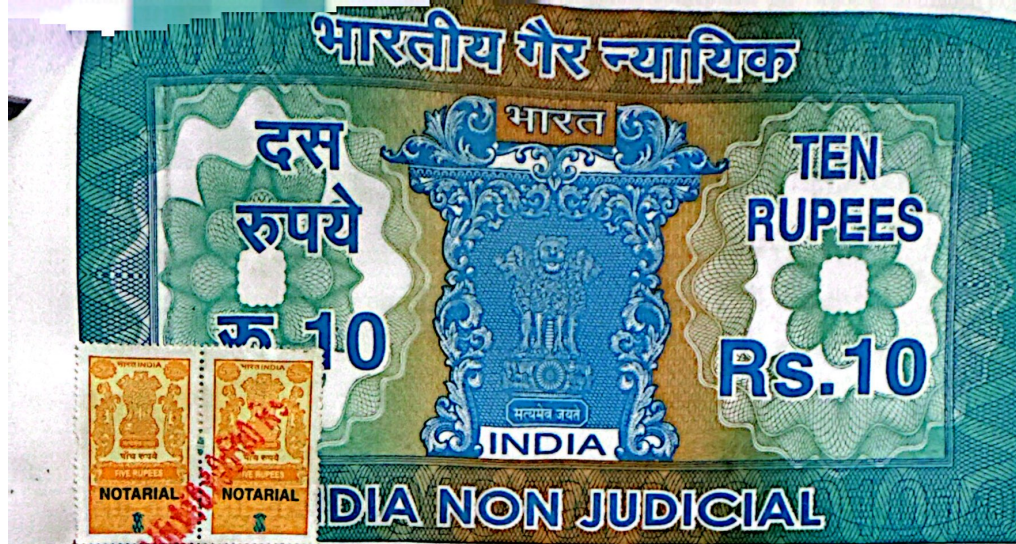

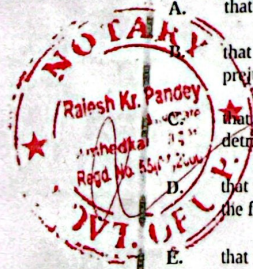

AFFIDAVIT

I, Gargi D/o Devendra kumar, resident of 3/59 Jain Mandir Gali, Lekhranj Nagar, Aligarh (U.P.), Pin Code-202001 presently posted as Civil Judge (SD) (FTC), Ambedkar Nagar do hereby solemnly affirm that:

- A. that the Applicant is a citizen of India;
- B. that the applicant may not, or is not likely to, engage outside India in activities prejudicial to the sovereignty and integrity of India;
- C. that the departure of the applicant from India may not, or is not likely to, be detrimental to the security of India;
- D. that the presence of the applicant outside India may not, or is not likely to, prejudice the friendly relations of India with any foreign country;
- E. that the applicant has, at any time during the period of five years immediately preceding the date of her application, not being convicted by a court in India for any offence involving moral turpitude and sentenced in respect thereof to imprisonment for not less than two years;

- G. that a warrant or summons for the appearance, or a warrant for the arrest, of the applicant has not been issued by a court under any law for the time being in force or that an order prohibiting the departure from India of the applicant has not been made by any such court.

- I. that there is no possibility of arising embarrassing position before the Government of U.P. due to my visit to any foreign country.
- J. that the Issuance of "Identity Certificate" for obtaining a passport was never refused to me.
- K. that I have never visited any foreign country earlier.
