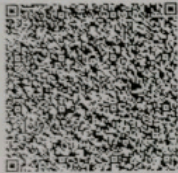

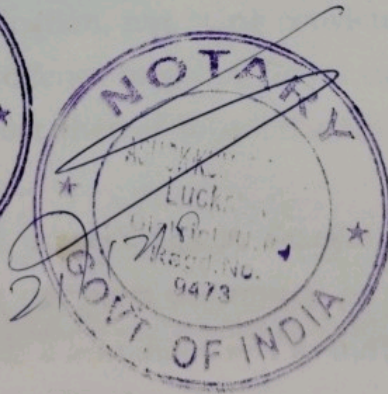

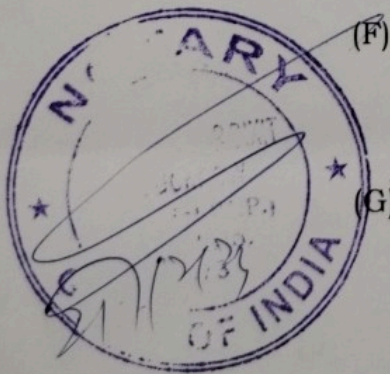
AFFIDAVIT

- (A) That the deponent is a citizen of India.

(G) That a warrant or summons for the appearance, or a warrant for the arrest, of the deponent has not been

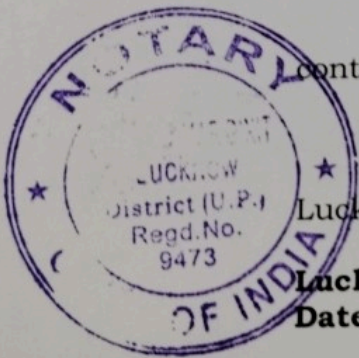
