
(1) The undersigned joined the Service on 14-06-2006 in pursuance to Hon'ble High Court's notification.

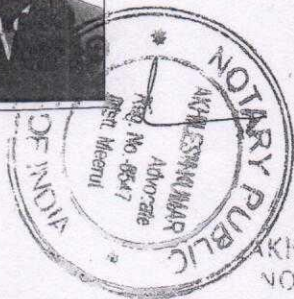
