Respected Sir,

With utmost respect and regard, I am submitting information as directed by letter No. 1890/IV-3822/Admin (A) Dated 21.12.2012 regarding :-

1. Loan arrangement letter taken against the purchase of Car.
2. Complete and attested copy/copies of pass-book (photo copies of present & previous pass books) indicating the particulars entry/entries of payment(s) made against purchase of the car, by disclosing the source of money deposited/credited to her account by giving details of the credits, in case any such credit exceeds the amount of her one month's salary.

In respect of Para 1, I am annexing Loan arrangement letter taken against the purchase of car of State Bank of India, Main Branch, District Etah which is also my Government Salary account as Annexure- 1.

In respect of information regarding Para 2, I am submitting self attested photo copies of present and previous pass book of my Government salary Account since I have joined this service as Annexure-II.

Details of entries of payments made against purchase of the car:-

- Booking amount of Rs. 40,000/- (Forty Thousand) was withdrawn on 18.04.2012 from my salary account.
- Car Loan of Rs. 900000/- (Rupees Nine Lacs) was disbursed by SBI Etah to my account on 24.07.12.
- Payment of Rs. 1301209/- (Rupees Thirteen Lac One Thousand Two Hundred and Nine) was made by SBI, Etah Through RTGS transfer to the car dealer on 24.07.2012 from my salary account.

- Rs. 35000/- (Rupees Thirty Five Thousand) was withdrawn for the payment of Registration fee on 13.08.12 from my salary account.
- Registration fee paid was Rs. 33916/- (Rupees Thirty Three Thousand Nine Hundred Sixteen) and car got registered on the same date i.e. 13.08.12.

In respect of credits which exceed my one month's salary, it is submitted that apart from Government arrears which are credited to my salary account, I have only one transaction which exceeding my one month's Salary and it is transaction dated 21.03.2012 of Rs. 200000/- (Two Lacs) through cheque which is given by my father Shri Y.P. Singh from his UCO Bank Account out of love and affection for the purpose of my marriage which got Solemnised on 24.04.2012. I am submitting photocopy of my father's Bank Account of this transaction as Annexure-III. There is no other transaction exceeding my one month's Salary except government salary and allowances arrears.

I am also submitting information send earlier to the Hon'ble Court according to circular letter no. 25/ Admin (A) dated 13.07.1988 as Annexure-IV.

All the annexures stated above are enclosed herewith for your kind perusal and information.
