

**Subject: Viva-voce for the posts of Civil Judge (Junior Division) - 2023-24**

Refer to your application for the above cited Examination.

1. You are hereby directed to report for the viva- voce at **02:30 P.M.** on **20.09.2024 (Friday)** at Auditorium near New Judge's Library at Punjab and Haryana High Court, Sector 01, Chandigarh. **Entry of candidates shall be from Gate No. 6 of Punjab & Haryana High Court, Chandigarh.**
2. Further you shall bring all the **original certificates/ documents i.e. Matric, 12<sup>th</sup>, Graduation, LL.B., LL.M., Domicile of Haryana, Caste Certificate etc. in support of your claim along with a set of attested photocopies, at the time of viva-voce.**
3. The candidates belonging to BC-A/BC-B category of Haryana are required to bring latest / updated Certificate as per notification No. 491-SW(1)2021 dated 17-11-2021 & Govt. instructions No. 22/132/2013-1GS-III dated 22.03.2022 (available on the website of C.S. Haryana i.e. <http://csharyana.gov.in>) issued by the Competent Authority during 2023-24 only.
4. The women candidates seeking reservation under SC/BC-A/BC-B category are required to submit the Caste Certificate issued by the Competent Authority from **Parental Side (Father's side)** only.
5. The candidates belong to EWS category should bring EWS certificate valid for year 2023-24 as per Govt. Instructions dated 25.02.2019.
6. (i). For the employees of Haryana Government who have not executed any bond with the State Government, No Objection Certificate from the employer is not required. However, self-declaration of such Govt. employees is required to be submitted to the effect that employees are not facing any disciplinary proceeding at the time of Interview. In case of employees, who have executed bond with the State Government, No Objection Certificate from Head of Department shall, however, be required.  
(ii) The candidate who joins service under Government, Quasi Government Organization, Public Sector undertakings after the submission of application and has executed a bond will have to produce No Objection Certificate from the employer on or before the date of interview, failing which he/she will not be interviewed.  
(iii) In case you have resigned from the service after sending the application form, a letter from the employer is required mentioning that you have resigned from the post and your resignation has been accepted.

Notes: -

1. **No TA / DA will be paid for attending the Viva-Voce.**
2. **No request by any candidate for the change of date for his / her viva-voce shall be entertained.**
3. **Presence in the interview / viva-voce on the specified date and time is mandatory, if a candidate remains absent, then his / her candidature will not be considered.**
