It is being run by THE ACT AND STATUTES,1986(as amended upto 2021)assented to by the Governor of Haryana on 14.09.2012 and published in Haryana Government Gazette, (Extra) on Oct 10,2012.(Please refer Annexure I).The University is providing important information through its website i.e. https://www.kuk.ac.in/index.php ,hence all the enclosed papers are available in public domain. The centre for distance education of the university is facilitating to the stakeholders by a dedicated website i.e. https://ddekuk.ac.in/index.php which has 'The Mandatory disclosures ' section too. The available online papers related to my LLM degree are being submitted stepwise in following manner- 1. The competent authority of the Kurukshetra University i.e. the executive council took the decision to establish the directorate of distance education for running distance education courses in different disciplines vide Execution Council Resolution no. 11(12) of 03.12.2008 (please refer Annexure II) 2. As per The University Grants Commission's letter vide ref.F.no.UGC DEB/KUK /HAR 2014 dated 01 September 2015 UGC has permitted Kurukshetra University to continue its open and distance learning programme for academic year 2015-16 and the university has notified the list of the courses for the same,in which the LLM course is stated at serial.no.34(please refer Annexure no. III) 3.As per the latest available online list of courses LLM again listed vide serial.no. B.VI.2 However it is also mentioned there that "only for continuing students of january 2021 session"(please refer Annexure IV). Since I was registered in 2021,this continuation is well applicable to me. Therefore ,I most humbly request you again to place before hon'ble high court my submitted papers for their kind consideration regarding inclusion of my LLM degree in service records. Regards
