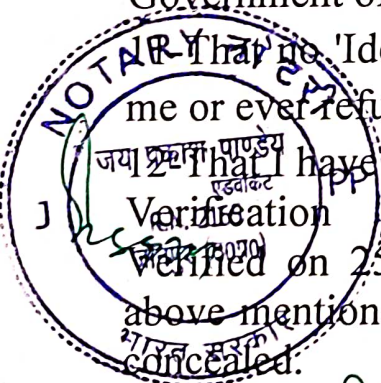
9-That I have never been repatriated from abroad back to India.

11-That no 'Identity Certificate' for obtaining a passport has been issued to me or ever refused.


