Respected Sir,

It is humbly submitted that my son Harshdeep Singh is working in Canada on a work permit and staying in a rented house at 9138,138B St. Surrey, BC, V3V 5T7 Canada. My wife Charanjeet Kaur also works in Kelowna BC on a work permit and resides at 1775, Swainson Road, Kelowna, BC V1P 1C5 BC, Canada. My daughter Simone Singh is studying at Queen Elizabeth Secondary School in Surrey, BC Canada in grade 12 and residing with her brother Harshdeep Singh. Thus, my family is living in Canada. It is necessary to mention here that there is a free education till class 12th in Canada.

I want to go to Canada in December 2024 to attend the Parent Advisory Council Meeting regarding my daughter Simone Singh's future career and spend some time with my family. My visit to Canada will not affect any judicial work because a link officer is appointed for every Court for such exigencies. I have strategically planned my trip so that the minimum working days of my court will be affected. The court will be closed from 25 December 2024 to 31 December 2024 due to Christmas Day and winter holidays, and from 1st January 2025 to 26th January 2025, the court will also be closed for a significant amount of that period. According to Hon'ble High Court Circular No.-16/ IV f-101/ Admin(A) dated 27.05.2017, abroad tour by any officer shall not be availed of during working days of court except in special circumstances. But my tour is not for pleasure. There is a Parent Advisory Council Meeting regarding the future career of my daughter Simone Singh, proposed in January 2025. As per school policy, parents must attend the meeting. If I do not attend the meeting that will be harmful to my daughter's career. That is why I must be there. My wife will come to attend the meeting from Kelowna.

My family is staying in a rented house, and I will be staying with my son and daughter at 9138 134B St Surrey. My wife will come to my son's residence and will be staying with us for the duration of my stay. So, there will be no expenditure on accommodation. My visit to Canada entails only a fare expenditure of approximately Two lac. I am enclosing my bank statement for your kind perusal.

It is humbly submitted that given the abovementioned special circumstances, I want to go to Canada from 25.12.2024 to 26.01.2025 after availing Earned Leave from 01.01.2025 to 24.01.2025 (with the prefix Christmas Day holiday 25.12.2024 & winter holidays 26.12.2024 to 31.12.2024 and suffix with fourth Saturday 24.01.2025 and Sunday 26.01.2025). My proposed visit to Canada will be commenced on 25.12.2024.

It is also submitted that; I visited Canada from 04.08.2024 to 01.09.2024 with the permission of the Hon'ble High Court and came back within the stipulated time. I already applied for a visa to visit Canada and the same was granted to me with validity till 01.10.2026. Therefore, I have a valid visa to visit Canada. I am submitting my application before time because the air ticket may be available at a cheaper rate.

In light of Hon'ble High Court Circular No.- 16/ IV f -101/ Admin(A) dated 27.05.2017, I declare the following,

(a) That, by my visit to Canada, no dilemma is likely to be created before the Government of India or before the Government of UP.

(b) That, my request to visit abroad was not refused to me earlier.

(c) That, I also applied for permission before the Hon'ble Court to visit Canada from 04.08.2024 to 01.09.2024 and the same was granted and I came back to India within the stipulated time.

In view of the abovementioned consideration, I humbly request to place my application before the Hon'ble Court to kindly consider my application to allow me to visit Canada to meet my family. I shall be highly obliged.
