May kindly see letter dated 01.09.2022 (at flag 'A') of Sri Bans Bahadur Yadav, Additional District & Sessions Judge, Mainpuri, received in compliance of Hon'ble Court's letter no. 10983/IV-2866/Admin(A) dated 31.08.2022(at flag 'B'), whereby he has informed that presently he is not willing to have requested G.P.F. withdrawal as the scheduled marriage of his daughter has broken due to unavailability of funds and he shall not be able to utilize same against said purpose.

In this context it is submitted that Sri Bans Bahadur Yadav had vide application dated 02.02.2022 (at flag 'C' submitted via E-servicesJO portal) requested for sanction of final withdrawal, amounting Rs.12,00,000/- from his G.P.F. A/c No. LJU-23178, to meet out the obligatory expenses relevant with marriage of his daughter which was scheduled to be solemnized on 21.05.2022.

It is further submitted that application dated 02.02.2022 of Sri Bans Bahadur Yadav, aforesaid was forwarded for kind perusal and approval of sanctioning authority vide office note dated 19.02.2022, upon which requested withdrawal was digitally approved vide Hon'ble Court's order dated 06.08.2022 (at flag 'D'), however by that time scheduled date of marriage had elapsed.

Moving forward, keeping in view the elapse of scheduled date of marriage, the sanction order dated 06.08.2022 was not communicated to Sri Bans Bahadur Yadav. Instead, upon receiving instructions from Hon'ble Lordship's chamber, vide Hon'ble Court's letter dated 31.08.2022 (flagged as 'B') Sri Bans Bahadur Yadav was requested to intimate the current requirement of instant withdrawal whereby vide instant letter dated 01.09.2022 (flagged as 'A'), he has informed the Hon'ble Court that he is not willing to have requested G.P.F. withdrawal as the scheduled marriage of his daughter has broken due to unavailability of funds and he shall not be able to utilize same against said purpose.

In this context, keeping in view the unfortunate break-off of marriage, it appears pertinent to mention here that though Sri Bans Bahadur Yadav had moved application regarding instant request much before the scheduled date of marriage, however, if he had moved a reminder on his request then it might have accelerated the sanctioning process. Nonetheless, since present situation is that the officer is not in need of requested funds, hence, it seems appropriate to annul said sanction order dated 06.08.2022.

In the view of aforesaid facts and circumstances, if approved by In-charge Joint Registrar(Judicial)(Budget), the matter may kindly be placed before Hon'ble Mr. Justice Anjani Kumar Mishra (Nominated Judge for Sanction of Temporary Advance/Final Withdrawal to the Judicial Officers from their GPF Account, of Mainpuri District), for His Lordship's kind perusal and order to the effect that Court's sanction order dated 06.08.2022 (flagged as 'D') may be annulled and Sri Bans Bahadur Yadav, aforesaid may be intimated accordingly in this respect ?
