May kindly see the letter dated 18.10.2019 of Sri. Kuwar Rohit Anand, the then Additional Civil Judge (Junior Division), Deoria, and presently posted as Civil Judge ( Junior Division), Dalmau at Raebareli, requesting for inclusion of his LL.M. qualification in his service records. In this connection, it is submitted that initially the documents, furnished by Sri. Kuwar Rohit Anand, Additional Civil Judge (Junior Division), Deoria, were not duly attested, thus inadmissible for inclusion of his qualification in his service records.

Thereafter, an online objection was raised by office of this Court and in reply, Sri. Kuwar Rohit Anand has further submitted the attested copies of LL.M mark-sheets (all the semesters) and copy of Degree (uploaded online on 01.07.2021 and 24.08.2021 respectively) for inclusion of his qualification in his service records, as supporting documents.

In this connection, it is submitted that Sri. Kuwar Rohit Anand, joined the U.P. Judicial Service on 09.07.2018, as Additional Civil Judge (Junior Division), Deoria. Besides, as evident from submitted attested copies of mark-sheet (all the semesters) and degree of LL.M (attached online on 01.07.2021 and 24.08.2021 respectively), Sri Kuwar Rohit Anand, completed three-year LL.M. course in the year 2017 and was subsequently awarded Degree from University of Delhi, New Delhi on 19.11.2018, thus the said qualification may be included in his service records.

It is further submitted that the Government of U.P. is the appointing authority of Judicial Officers, thus the said qualification of LL.M. Degree may be included in the service records of Sri. Kuwar Rohit Anand, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 18.10.2019 (attached online on 23.10.2019) of Sri. Kuwar Rohit Anand, Civil Judge (Junior Division), Raebareli, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may kindly be placed before Hon'ble Mr. Justice Siddharth, Administrative Judge, Raebareli, for His Lordship's kind perusal and order to the effect that copy of mark-sheets (all semesters) and the degree of LL.M (attached online on 01.07.2021 and 24.08.2021 respectively) as well as attested copy of form of U.P. Nyayik Sewa of Sri. Kuwar Rohit Anand, Civil Judge (Junior Division), Raebareli, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
