

## **Joint Registrar (J) (Budget)**

May kindly see the online application of Sushri Ankita Boudha, Civil Judge (Jr. Div.), Gonda by which she has submitted supplementary details/ papers in connection with information about purchase of a new Maruti Ciaz Alpha car in compliance of Court's order.

In this connection, it is submitted that earlier the officer had informed about purchase of a new Maruti Ciaz Alpha car on 16.06.2020 for Rs. 11,70,561/-, intimated through application dtd. 10.09.2020 was submitted before Hon'ble Mr. Justice Virendra Kumar-II, vide office note dated 09.10.2020. Thus, His Lordship has been pleased to order on 18.10.2020 that:-

***"The officer Sushri Ankita Boudha, Civil Judge (Jr. Div.), F.T.C., Gonda, who joined services on 16.12.2019. The officer is drawing gross salary amount to Rs. 84,355/- & her home take salary is Rs. 72,675/-.***

***The officer Sushri Ankita Boudha, Civil Judge (Jr. Div.), F.T.C., Gonda has sent information about purchase of a new Maruti Ciaz Alpha Car a renowned dealer, namely KTL Automobiles Pvt. Ltd. Cyber Heights, Vibhuti Khand, Gomti Nagar, Lucknow of costs amounting to Rs. 11,70,561/-. She took loan amounting to Rs. 9,50,000/- from State Bank of India, Civil Lines, Gonda and she is paying installment amounting to Rs. 15,212/- per month. She has to pay it in 84 installments.***

***She has attached her statement of account from 16.06.2020 upto 22.06.2020 in which the balance has been shown Rs. 1,02,916/- only. The officer has to provide statement of account from her date of joining i.e. 16.12.2019 upto date. She has to clarify whether she has any liability and the details of family members be also furnished within a month. She has paid amount of Rs. 65,000/- from her saving bank account and Rs. 1,55,561/- in kind of cash. The source of income has been shown from her saving bank. She has to clarify how she paid Rs. 1,55,561/- in kind of cash, because the balance is shown only Rs. 1,02,916/-. She has to provide the details of household expenses also. There is no entry regarding transfer of installment to the loan account from her saving bank account."***

The order was communicated online to the officer.

In reply of the Court's order dtd. 18.10.2020, Sushri Ankita Boudha, has stated that she has purchased the abovementioned vehicle out of her savings & loan amount on 16.06.2020 for Rs. 11,70,561/- in total. Earlier, in her application she has stated that Rs. 9,50,000/- has been taken by her as loan amount & rest Rs. 2,20,561/- has been paid out of her savings. But, she has forgotten to give some very important details in her application that she has been provided a discount of Rs. 10,000/- by the car dealer as corporate offer & Rs. 39,000/- is stated to have been discounted as the said vehicle has met an accident & its bonnet has been changed by the dealer. Moreover, her brother has booked the said vehicle on 04.03.2020 for Rs. 11,000/-, which is stated to have been returned by her on 12.03.2020 to him. Thereafter, when the papers of the vehicle got ready for delivery on 23.02.2020, at that time lockdown took place, due to which she was unable to get the same. Again, on 16.06.2020, when she reached to purchase the said vehicle, the car dealer told her that no other car was available at that time except the said car. Thus, the dealer has provided her a discount of Rs. 39,000/- due to the accident. Earlier she has forgotten to disclose this fact as her mistake was inadvertent. Therefore, she has paid Rs. 1,36,000/- out of her A/c & Rs. 35,000/- has been paid in cash. The source of Rs. 35,000/- is stated to have been her regular savings. Earlier, she has added the amount discounted by the dealer in the total price of the car. Thus, Rs. 1,36,000/- Rs. 35,000/- Rs. 10,000/- Rs. 39,000/- = Rs. 2,20,000/-.

The officer has also provided details of her family members i.e. her family comprises of 06 members- her father, mother, elder sister & two younger brothers. Her father looks after the livelihood of the family. Her elder sister is married & is residing with her in-laws. Her younger brother runs a business & he too helps in the livelihood of the family along with his father. Her youngest brother is studying in B.A.-IInd year & the officer sometimes helps financially in the same. She does not bears the whole responsibility of her family but being a daughter she too partially helps in it. She is unmarried & is living all alone. Her expenditures at the time of purchase of the said car is approx. 7-8 thousand rupees but sometimes she invests her money in online shopping or any other household items. Now, too she resides all alone. The officer has also enclosed copy of statement of A/c right from her date of joining till now (copy can be seen as attachment).

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Ajai Kumar Srivastava-I,
