May kindly see the online application of Sri Mayank Singh, Nyayadhikari-Gram Nyayalaya, Bilaspur Rampur who joined service on 16.11.2019, drawing gross salary of Rs. 84,388/- & take home salary of Rs. 73,675/- regarding information about purchase of new Hyundai CRETA 1.5 Diesel car, allotted reg. no. UP21CH4007, intimated through application dated 16.09.2020.

Through his application, Sri Mayank Singh has submitted information about purchase of new car on 10.07.2020 by giving point wise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from Arjun Vasu Hyundai, opposite Modern Public School Delhi Road, Moradabad who is an authorised dealer, for Rs. 11,31,000/- (copy of invoice can be seen as attachment), source of money of which is that Rs. 4,00,000/- has been taken as loan from Bank of Baroda, Moradabad repayable in 48 installments of Rs. 9635/- (copy of 'loan arrangement letter' can be seen as attachment), Rs. 10,000/- is stated to have been paid in cash as booking amount (copy of receipt can be seen as attachment), Rs. 4,00,000/- through cheque no. 479615 & Rs. 2,77,000/- through cheque no. 479616 are stated to have been paid to the dealer out of his S.B. A/c, source of which is that Rs. 5,25,000/- is stated to have been transferred to the officer's A/c as gift by his father for the purchase of the aforementioned car & Rs. 1,52,000/- is stated to have been accumulated by him after joining of this service (copy of consent letter of his father along with statement of A/c of the officer can be seen as attachment), Rs. 46,000/- is also stated to have been paid to the Insurance company in cash out of his mother's A/c. The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Deepak Verma, Administrative Judge, Rampur also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district Rampur for His Lordship's kind perusal and information under rule 24(2) of U.P. Government Servant's Conduct Rules, 1956?
