May kindly see letter dated 30.09.2020 (attachment under the heading-application for inclusion of Ph.D. Degree) alongwith attested copy of degree of Ph.D and thesis submission certificate (attachment under the heading-attested copy of Ph.D. Degree and attested copy of thesis submission certificate) of Sushri Nidhi Yadav, the then Civil Judge (Senior Division), Kanpur Nagar and presently posted as Civil Judge (Senior Division), Kunda-Pratapgarh regarding inclusion of degree of Doctor of Philosophy (Ph.D.) in Law in her service records and add prefixing word 'Doctor' before her name.

Sushri Nidhi Yadav, aforesaid, had earlier requested for inclusion of Ph.D. Degree in her service records vide her letter dated 30.09.2020 (attachment under the heading-application for inclusion of Ph.D. Degree) and uploaded self attested copy of Ph.D. Degree. Thereafter, she was requested to upload attested copy of Ph.D. Degree (not self attested) and also thesis submission certificate vide online office note dated 22.02.2021. In response to the above, she has now uploaded the same on 03.03.2021.

In the context of the above, it is submitted that Sushri Nidhi Yadav, aforesaid, joined U.P. Judicial Services on 13.01.2017 as Metropolitan Magistrate, Kanpur Nagar. Besides, as apparent from submitted attested copy of degree of Ph.D, Sushri Nidhi Yadav was awarded the degree of Doctor of Philosophy (Ph.D) in Law for the topic entitled "Reformation of prisoners in State of U.P.:Problems and Prospects." in year 2015 from Aligarh Muslim University, Aligarh and was awarded Degree on 27.02.2016. Nevertheless, relevant details about course completion is not mentioned in her application form of U.P.Nyayik Sewa/UPHJS, thus, the said qualification is required to be included and the prefixing word 'Doctor' be added before the name in her service records.

It is further submitted that the appointing authority of Judicial Officers is the Government of U.P., thus, the qualification of Ph.D. degree may be included and the prefixing word 'Doctor' be added before the name in service records of Sushri Nidhi Yadav, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 30.09.2020 uploaded online on 04.10.2020. Sushri Nidhi Yadav, the then Civil Judge (Senior Division), Kanpur Nagar and presently posted as Civil Judge (Senior Division), Kunda-Pratapgarh may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may be laid before the Hon'ble Mr. Justice Ajay Bhanot, Administrative Judge, Pratapgarh, for kind perusal and approval to the effect that the copy of aforesaid letter dated 30.09.2020 (attachment under the heading-application for inclusion of Ph.D. Degree) along with the attested copy of Ph.D degree (attachment under the heading-attested copy of Ph.D. Degree) as well as attested copy of form of U.P.Nyayik Sewa of the then Civil Judge (Senior Division), Kanpur Nagar and presently posted as Civil Judge (Senior Division), Kunda-Pratapgarh, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter.
