May kindly see letter dated 01.09.2020 (uploaded on 16.10.2020 at SL No. 01) along-with attested copies of mark-sheets (Part I & II) (**uploaded at SL No. 03 & 04**) and degree of LL.M (**uploaded at SL No. 05**) of Sri Pradeep Kumar Kushwaha, the then Civil Judge (Jr. Div.), Mohammadabad- Ghazipur and presently posted as Addl. Civil Judge (Senior Div.)/ACJM. Gautambuddha Nagar, requesting for inclusion of LL.M qualification in his service-records and subsequent grant of three advance increments.

Sri Pradeep Kumar Kushwaha, aforesaid, had earlier requested for inclusion of LL.M. Qualification in his service records on 16.10.2020 and uploaded attested copy of mark-sheet (Part II only) and provisional Degree of LL.M. Qualification (**uploaded on 16.10.2020 at SL No. 02**). **Thereafter, he was requested to upload attested copies of mark-sheets (all semesters/years) and original degree (not provisional) of LL.M. qualification vide online office note dated 02.03.2021. Eventually,** relevant LL.M. credentials i:e attested copies of mark-sheets (Part I & II) (**uploaded at SL No. 03 & 04**) and LL.M. Degree (**uploaded at SL No. 05**) **accompanied with prayer for inclusion of subject qualification in his service records (at SL No. 01). Also, he was granted permission to complete LL.M. Degree vide Hon'ble Court's letter No. 18128/IV-4265/Admin (A-4) dated 19.12.2018.**

In this context, it is submitted that Sri Pradeep Kumar Kushwaha, aforesaid, joined U.P. Judicial Services on 01.02.2017 as Addl. Civil Judge (Junior Div.), Ghazipur. Besides, as apparent from submitted attested copies of mark-sheets and degree of LL.M (**online attached on 16.03.2021 at SL No. 03, 04 & 05**), Sri Pradeep Kumar Kushwaha, completed LL.M. course in year 2019 and was subsequently awarded Degree from Kurukshetra University, Kurukshetra (Haryana) on 31.12.2020. Nevertheless, relevant details about course completion is not mentioned in his application form of U.P. Nyayik Sewa, thus, said qualification is required to be included in his service records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M degree, may be included in the service records of Sri Pradeep Kumar Kushwaha, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 01.09.2020 of Sri Pradeep Kumar Kushwaha, Addl. Civil Judge (Senior Div.)/ACJM. Gautambuddha Nagar, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may be laid before Hon'ble Mr. Justice Manish Mathur, Administrative Judge, Gautambuddha Nagar, for kind perusal and if His Lordship approves for order to the effect that copy of aforesaid letter dated 01.09.2020 along with attested copies of mark-sheets and degree of LL.M. (**online attached on 16.03.2021 at SL No. 03, 04 & 05**), as well as attested copy of form of U.P.Nyayik Sewa of Sri Pradeep Kumar Kushwaha, Addl. Civil Judge (Senior Div.)/ACJM. Gautambuddha Nagar, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
