

**Joint Registrar (Judicial) (Budget)**

May kindly see the online application of Sushri Roopali Singh, the then Additional Civil Judge (Junior Division), Rampur presently posted as Nyayadhikari, Gram Nyayalaya, Bilaspur- Rampur who joined service on 15.11.2019, drawing gross salary of Rs. 84,188/- & take home salary of Rs. 73,675/- regarding information about purchase of a new Hyundai Venue 1 L Turbo Petrol car, allotted reg. no. UP21CH4497, intimated through application dated 19.10.2020.

Through her application, Sushri Roopali Singh has submitted information about purchase of a new car on 15.07.2020 by giving point wise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by her from M/s Arjun Vasu Automobiles Pvt. Ltd., Opp. Modern Public School, Delhi Road, Moradabad who is an authorised dealer, for Rs. 10,95,380/- (copy of invoice can be seen as attachment), source of money of which is the bank loan from Punjab National Bank, Rampur of Rs. 9,21,000/- repayable in 60 EMIs of Rs. 18,415/- (Copy of loan arrangement letter can be seen as attachment), Rs. 1,69,380/- is stated to have been paid out of her own S.B. A/c no. 9170000100022136, PNB (copy of statement of A/c of the officer can be seen as attachment) & rest Rs. 5000/- is stated to have been paid in cash on 13.07.2020.

The matter was previously submitted to Hon'ble Mr. Justice Faiz Alam Khan, Nominated Judge, through detailed office note dated 23.03.2021, placed above but as per order dated 28.10.2021 of Hon'ble The Chief Justice, such matters i.e. work relating to 'Disposal of the matters of the Judicial Officers, wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956" is assigned to Hon'ble Administrative Judge of the district concerned, where the concerned Judicial Officer is posted, thus the same got reverted without any order. As such, the matter is now likely to be placed before Hon'ble The Administrative Judge of the district concerned.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Deepak Verma, Administrative Judge, Rampur, also nominated for 'Disposal of the matters of the Judicial Officers, wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956" for the district Hathras, for His Lordship's kind perusal and information under Rule 24 (2) U.P. Government Servant's Conduct Rules, 1956?
