May kindly see the online requisition dated 23.10.2020 of Smt. Megha Aggarwal, the then Civil Judge (Junior Division), Bulandshahar, presently posted as Judicial Magistrate, Lucknow, requesting for sanction of three advance increments vide Case Id No. 09522020 (Old Case Id 1260). In compliance of same, Smt. Megha Aggarwal furnished unattested copy of her LL.M. Degree.

Thereafter, an online objection, dated 03.03.2021, was raised by the office of the Court asking Smt. Megha Aggarwal to furnish the attested copies of Mark-sheets of all the years and copy of Degree along with fresh application praying for inclusion of LL.M. Degree in her service records. In compliance of same, Smt. Megha Aggarwal, vide dated 24.03.2021, submitted the attested copies of Mark-sheets of all the four semesters and copy of Degree along with an application praying for inclusion of LL.M. qualification in her service records vide same Case Id No.09522020 (Old Case Id 1260).

Further, another objection, dated 28.04.2022, was raised by the office asking Smt. Megha to clarify the reason behind the same date of issuance of Mark-sheets of all the semesters. In compliance of same, Smt. Megha, vide dated 28.04.2022, submitted the reason that since there was spelling mistake of her name in Mark-sheets, she had applied for corrected copies of the same.

In this connection, it is submitted that Smt. Megha Aggarwal, joined the U.P. Judicial Service on 18.06.2018, as Additional Civil Judge (Junior Division), Bulandshahar. Besides, as evident from submitted copies of Mark-sheets (four semesters) and Degree of LL.M., Smt. Megha Aggarwal completed two years LL.M. course, for the academic session 2015-2017, and was subsequently awarded Degree from Chaudhary Charan Singh University, Meerut on 17.11.2017 for the examination year 2017, thus said qualification may be included in her service records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M. Degree may be included in the service records of Smt. Megha Aggarwal, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid online requisition dated 23.10.2020 of Smt. Megha Aggarwal, Judicial Magistrate, Lucknow may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may kindly be placed before the Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Lucknow, for His Lordship's kind perusal and order to the effect that a copy of his online requisition along with copy of Mark-sheets (four semesters) and Degree of LL.M. as well as attested copy of form of U.P. Nyayik Sewa of Smt. Megha Aggarwal, Judicial Magistrate, Lucknow, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
