May kindly see the online application of Smt. Priyanka Sharma, Additional Civil Judge (Junior Division), Bulandshahar who, joined service on 16.12.2019, drawing gross salary of Rs. 84,188/- & take home salary of Rs. 71,675/- regarding information about purchase of a new Maruti Ciaz Smart Hybrid Delta car, allotted reg. no. UP13 BQ2346, intimated through application dated 23.11.2020.

Through her application, Smt. Priyanka Sharma has submitted information about purchase of a new car on 28.08.2020 by giving pointwise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by her from Rohan Motors Ltd. E-41, Site-4, Industrial Area, Kasna Road, Greater Noida, who is a regular & reputed dealer, for Rs. 10,04,580/- (copy of invoice can be seen as attachment), source of money of which is that Rs. 8,00,000/- has been taken as loan from State Bank of India, Bulandshahar repayable in 60 EMIs of Rs. 16,259/- (copy of loan arrangement letter can be seen as attachment), rest Rs. 2,04,580/- is stated to have been paid out of her own S.B. A/c no. 39015322741 (copy of statement of A/c can be seen as attachment). Late registration penalty of Rs. 14,584/- has been paid by the dealer. The dealer from whom the said car has been purchased by the officer is neither related to her in any way nor any case is pending/decided in her court.

The matter was submitted before Hon'ble Mr. Justice Om Prakash-VII vide detailed office note dated 03.09.2021, upon which His Lordship has been pleased to order:-

"Office to report as to whether officer has submitted property statement timely or not."

In this connection, it is submitted that the officer has already submitted property statement on case ID no. 2836 at the time of joining (joining date-16.12.2019) which was due, but belatedly, for which she has not submitted any reasons for delay.

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Om Prakash-VII, Administrative Judge, Bulandshahar also nominated for "Disposal of the matters of Judicial Officers, wherein permission /information for sale or purchase of movable/ immovable property and permission/information to accept gift under U.P. Government Servants' Conduct Rules 1956", for His Lordship's kind perusal & further order in the matter of information about purchase of a new Maruti Ciaz Smart Hybrid Delta car?
