

**Joint Registrar(J) (Budget)**

May kindly see the online application dated 24.11.2020 received from Sri Nitin Kumar Rathi, Addl. Civil Judge (Jr.Div.), Aligarh regarding grant of permission to appear in Viva-Voce of Delhi Judicial Service Examination-2019.

Sri Nitin Kumar Rathi in his letter has stated that he has been selected for the Viva-Voce examination for Delhi Judicial Service Examination-2019 scheduled to be held on 04 December 2020 and attached provisional interview letter for the same. He has appeared in Mains examination for the same before joining the U.P. Judicial Services and wants to permit him to appear for the Viva-voce examination for Delhi Judicial Service Examination-2019. The Registrar General of High Court, Delhi has intimated that he has to submit 'No objection Certificate' if working in a Government organization by submitting copy of interview call letter and admit card of the interview (submitted as attachment). Thereafter, a objection was raised through which he was asked to intimate as to whether he had appeared in the Viva-Voce examination or not, to this Court, for taking further necessary action may be taken in the matter.

In reply, the officer has stated he has appeared in vivo-voce for Delhi Judicial Service Examination 2019 on 4 December 2020, in anticipation of Court's permission.

In this connection, it is submitted that the officer has joined the U.P. Judicial Service on 26.02.2020. As he has already appeared in the mains examination of Delhi Judicial Service Examination-2019 before joining the U.P. Judicial Service and qualified for the Viva-Voce examination (interview) of the same, his case for issuance of 'No objection Certificate' for the same may be taken favorably. The officer has also appeared in vivo-voce for Delhi Judicial Service Examination 2019 on 4 December 2020, in anticipation of Hon'ble Court's permission. He has, therefore requested to place his application before the Hon'ble Court for grant of ex-post facto permission to appear in Viva-Voce of Delhi Judicial Service Examination-2019.

Under the facts and details mentioned above, may, therefore, if approved, the instant matter be laid before Hon'ble Mr. Justice Vivek Kumar Birla, Administrative Judge, Aligarh Judgeship for His Lordship's kind perusal and orders to the effect that ex-post fact permission be granted and 'No objection Certificate' be issued in favour of Sri Nitin Kumar Rathi, Addl. Civil Judge (Jr.Div.), Aligarh to appear in Viva-Voca (Interview) of Delhi Judicial Service Examination-2019, already held, as required and requested by him?
