May kindly see the online application of Sushri Sulochna Verma, presently posted as Civil Judge (Junior Division), Ayodhya (Faizabad) who joined service on 14.12.2019, drawing gross salary of Rs. 84,188/- & take home salary of Rs. 72,675/- regarding information about purchase of a new Hyundai CRETA 1.5 car, allotted reg. no. UP34BD8006, intimated through application dated 16.01.2021.

Through her application, Sushri Sulochna Verma has submitted information about purchase of a new car on 08.09.2020 by giving pointwise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by her from Premier Car Sales Ltd. (BEEAAR Hyundai), Brahamdeep Hotel Jamayatpur NH-24, Sitapur who is an authorised dealer, for Rs. 15,70,727/- (copy of invoice can be seen as attachment), source of money of which is Rs. 12,00,000/- has been taken as loan from SBI, Bahraich, repayable in 72 EMIs of Rs. 21,100/- (copy of loan arrangement letter can be seen as attachment), Rs. 3,70,727/- in total is stated to have been paid out of his own S.B. A/c no. 36183849312 (copy of passbook along with receipts of payment can be seen attachment. (i.e. Rs. 30,000/- has been paid as booking amount, Rs. 3,14,000/- as down payment and rest Rs. 26,727/- is stated to have been paid through cheque number 719105, was later paid in cash by him when the dealer was unable to draw the payment from bank.) The dealer from whom the said car has been purchased by the officer is neither related to her in any way nor any case is pending/decided in her court.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Manish Mathur, Administrative Judge, Faizabad also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956" for the district Faizabad, for His Lodship's kind perusal and information under Rule 24 (2) of U.P. Government Servant's Conduct Rules, 1956 ?
