UP65DX5829, intimated through application dated 26.11.2020.

Through his application, Sushri Arpita Singh has submitted information about purchase of a new car on 18.10.2020 by giving pointwise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by her from Hans Honda, Pama Complex, DLW Road, Lahartara, Varanasi, source of money of which is that Rs. 13,20,000/- has been taken as loan from SBI, Varanasi, repayable in 84 EMIs of Rs. 20,706/- (Copy of 'Loan Arrangement Letter' can be seen as attachment), Rs. 5,000/- is stated to have been paid as booking amount through UPI on 07.09.2020 & rest Rs. 1,80,000/- is stated to have been paid through cheque no. 812664 out of her own S.B. A/c no. 32214997516 (Copy of statement of A/c can be seen as attachment). The dealer from whom the said car has been purchased by the officer is neither related to her in any way nor any case is pending/decided in her court.

It is also submitted that earlier the matter has been submitted before Hon'ble Mr. Justice Mohd. Faiz Alam Khan, Nominated Judge for the purpose vide office note dated 02.07.2021, but the same has been returned due to change of nomination and it is now likely to be submitted before Hon'ble the Administrative Judge concerned as per the order of nomination passed by Hon'ble The Chief Justice vide order dated 28.10.2021.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Dr. Justice Kaushal Jayendra Thaker, Administrative Judge, Varanasi, also nominated for "Disposal of the matters of Judicial Officers wherein permission/information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956" for the district, for His Lordship's kind perusal and information under Rule 24 (2) U.P. Government Servant's Conduct Rules, 1956?
