

## **Joint Registrar (J) (Budget)**

May kindly see the above online note dtd. 09.06.2021 of Dr. Laxmi Kant Rathaur, the then Additional District Judge, Ghazipur presently posted as Special Judge (E.C. Act), Ghazipur by which he has submitted supplementary details in connection with grant of permission to sell his old Bajaj chetak scooter, Mahindra jeep as well as his Tata Indigo car & purchase a new one and order of His Lordship about the same, which is as follows:-

***“Officer shall inform as to whether the purchaser is related to him or any of the case of purchaser is pending and decided in his Court or not”.***

The order was communicated online to the officer.

In reply of the Court's order, the officer has stated that the proposed purchaser does not belong to him. No any his case pending before him nor decided by him.

As such, the matter is now required to be submitted again to Hon'ble Court for further order, as proposed in earlier office note dated 09.06.2021, by taking into consideration the present reply, as submitted by the officer in compliance of Hon'ble Court's order/query.

May, therefore, if approved, the matter be laid before Hon'ble Mr. Justice Rajesh Singh Chauhan, Administrative Judge, Ghazipur, also nominated for "Disposal of the matters of the Judicial officers wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956", for His Lordship's kind perusal and, if His Lordship approves, Dr. Laxmi Kant Rathaur, Special Judge (E.C. Act), Ghazipur be granted permission to sell his old Bajaj chetak scooter bearing reg. no. UP 78E/9001, Mahindra jeep bearing reg. no. UP 77/6833 as well as his Tata Indigo car bearing reg. no. UP 78BB/3614, to Sri Ravindra Kumar S/o Sri Shripal, R/o Kesari Khera, Krishna Nagar, Kanpur Road, Lucknow who owns a workshop in the name of R.K. Motors, Bargawan Near Distt. Cooperative Bank, Barabirwa, Kanpur Road, Lucknow for a sum of Rs. 2,28,000/- in total i.e. (scooter for Rs. 8,000/-, jeep for Rs. 60,000/- & car for Rs. 1,60,000/-), as requested, subject to the condition that the relevant papers in connection with the sale transaction shall be furnished immediately on completion of the transaction.
