May kindly see the online application of Sri Asif Iqbal Rizvi, Additional District & Sessions Judge, (FTC) Mau who joined service on 28.08.2009, drawing gross salary of Rs. 1,43,739/- & take home salary of Rs. 1,09,405/- regarding information about purchase of a new ERTIGA SMART HYBRID Vxi car, allotted reg. no. UP54 AL6030, intimated through application dated 04.12.2020.

Through his application, Sri Asif Iqbal Rizvi has submitted information about purchase of a new car on 21.08.2020 by giving pointwise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from AGR Automobiles Pvt. Ltd., B.38/2-A, Mahamoorganj, Varanasi for Rs. 9,77,858/- (copy of invoice can be seen as attachment), source of money of which is that Rs. 6,00,000/- through cheque no. 475495 & Rs. 56,327/- (for insurance) through cheque no. 475496 are stated to have been issued by his wife Smt. Shabih Zehra, who is also posted as Additional District Judge, Mau in favour of Shriram General Insurance Co. Ltd. Rest Rs. 3,78,500/- is stated to have been paid out of his own S.B. A/c through cheque no. 855662 by NEFT/RTGS (copy of statement of A/c of both of himself as well as his wife can be seen as attachment). It is noteworthy that the insurance was not purchased from AGR Motors because necessary add ons were not included in its insurance policy. So, Rs. 59,369/- was refunded by cheque no. 916807 after final calculation was made. The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Ali Zamin, Administrative Judge, Mau, also nominated for 'Disposal of the matters of the Judicial Officers, wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956' for the district Mau, for His Lordship's kind perusal and information under Rule 24 (2) U.P. Government Servant's Conduct Rules, 1956?
