May kindly see online requisition dated 09.12.2020 along-with attested copies of Mark-sheets (both semesters) and Degree of LL.M qualification (uploaded online on 06.03.2021) of Sri Vikash Kumar Singh, the then Civil Judge (Junior Division), Garotha- Jhansi, presently posted as Civil Judge (Senior Division), Hapur, requesting for inclusion of LL.M qualification in his service-records.

Sri Vikash Kumar Singh, aforesaid, had earlier requested for inclusion of LL.M. Qualification in his service records vide his online letter dated 09.12.2020 and uploaded self attested copies of mark-sheets (both semesters) and Degree of LL.M. Qualification (uploaded online on 09.12.2020). Thereafter, an objection was raised by the office to re-submit the attested (not self-attested) copies of Mark-sheets (both semesters) and Degree of LL.M. accompanied with prayer for inclusion of LL.M. Qualification in his service-records vide online office note dated 03.03.2021. Now all relevant LL.M. Credentials has been uploaded by concerned Judicial Officer.

In this context, it is submitted that Sri Vikash Kumar Singh, aforesaid, joined U.P. Judicial Services on 10.07.2017 as Civil Judge (Junior Division), Jhansi. Besides, as apparent from submitted attested copies of Mark-sheets (both semesters) and Degree of LL.M. qualification, Sri Vikash Kumar Singh, completed LL.M. course in year 2017, for the academic session 2016-2017, and was subsequently awarded Degree from Dr. Ram Manohar Lohiya National Law University, Lucknow on 14.07.2017. Nevertheless, relevant details about course completion is not mentioned in his application form of U.P. Nyayik Sewa, thus, said qualification is required to be included in his service records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M Degree, may be included in the service records of Sri Vikash Kumar Singh, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 09.12.2020 of Sri Vikash Kumar Singh, the then Civil Judge (Junior Division), Garotha- Jhansi and presently posted as Civil Judge (Senior Division), Hapur may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may be laid before Hon'ble Mrs. Justice Saroj Yadav, Administrative Judge, Hapur, for Her Lordship's kind perusal and order to the effect that copy of his online requisition dated 09.12.2020 along with attested copies of Mark-sheets (both semesters) and Degree of LL.M., as well as attested copy of form of U.P.Nyayik Sewa of Sri Vikash Kumar Singh, the then Civil Judge (Junior Div.), Garotha- Jhansi and presently posted as Civil Judge (Senior Div.), Hapur, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
