May kindly see the online application of Smt. Pallavi Singh, Additional Civil Judge (Senior Division)/ACJM, Ayodhya (Faizabad) who, joined service on 15.03.2017, drawing gross salary of Rs. 90,979/- & take home salary of Rs. 75,356/- regarding information about purchase of a new Eco Sportz 1.5 Diesel TIT MT Sports Pack BS-VI car, intimated through application dated 12.12.2020.

Through his application, Smt. Pallavi Singh has submitted information about purchase of a new car on 06.11.2020 by giving point wise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by her from Brijraj Auto Pvt. Ltd., 2 Sardar Patel Marg, Civil Lines, Allahabad who is an authorised dealer, for Rs. 13,50,000/- (copy of invoice can be seen as attachment), source of money of which is that Rs. 10,00,000 is stated to have been taken as loan from Union Bank of India, repayable in 84 monthly installments of Rs. 15,215/- (copy of 'loan arrangement letter' can be seen as attachment), Rs. 2,00,000/- & 21,000/- are stated to have been paid out of her PNB A/c & Rs. 1,00,000/- is stated to have been paid out of her joint A/c of UBI ( copy of statement of A/c of both PNB & UBI can be seen as attachment). It is pertinent to mention here that Rs. 1,00,000/- is stated to have been taken as unconditional loan from her mother & the same has been transferred by her mother in two installments) (copy of 'consent letter' can be seen as attachment) & rest Rs. 29,000/- is stated to have been paid in cash. The dealer from whom the said car has been purchased by the officer is neither related to her in any way nor any case is pending/decided in her court.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Manish Mathur, Administrative Judge, Faizabad also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district Faizabad, for His Lordship's kind perusal and information under Rule 24(2) of U.P. Government Servant's Conduct Rules, 1956?
