

## **Joint Registrar(J)(Budget)**

May kindly see letter dated 14.12.2020 along-with attested copies of mark-sheets (all semesters/years) and degree of LL.M qualification **(uploaded on 09.03.2021 at SL No. 02)** of Sri Utkarsh Singh, Addl. Civil Judge (Junior Div.), Mau, requesting for inclusion of LL.M qualification in his service-records.

Sri Utkarsh Singh, aforesaid, had earlier requested for inclusion of LL.M. Qualification in his service records on 14.12.2020 uploading self attested copies of mark-sheets (all semesters) and Degree of LL.M. Qualification **(uploaded on 14.12.2020 at SL No. 01)**. Thereafter, he was requested to upload attested copies of mark-sheets (all semesters/years) and Degree of LL.M. Qualification accompanied with prayer for inclusion of same in his service-records vide online office note dated 03.03.2021. In response, all relevant LL.M. credentials i.e. mark-sheets (all semesters/ years) and Degree of LL.M. Qualification has been uploaded by him on **(09.03.2021 at SL No. 02)**.

In this context, it is submitted that Sri Utkarsh Singh, aforesaid, joined U.P. Judicial Services on 16.11.2019 as Addl. Civil Judge (Junior Div.), Mau. Besides, as apparent from submitted attested copies of mark-sheets and degree of LL.M **(uploaded on 09.03.2021 at SL No. 02)**, Sri Utkarsh Singh, completed LL.M. course in year 2018 and was subsequently awarded Degree from University of Lucknow, Lucknow on 16.10.2019. Nevertheless, relevant details about course completion is not mentioned in his application form of U.P. Nyayik Sewa, thus, said qualification is required to be included in his service records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M degree, may be included in the service records of Sri Utkarsh Singh, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 14.12.2020 of Sri Utkarsh Singh, Addl. Civil Judge (Junior Div.), Mau, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may be laid before Hon'ble Mr. Justice Piyush Agrawal, Administrative Judge, Mau, for kind perusal and if His Lordship approves for order to the effect that copy of aforesaid letter dated 14.12.2020 along with attested copies of mark-sheets and degree of LL.M. **(uploaded on 09.03.2021 at SL No. 02)**, as well as attested copy of form of U.P.Nyayik Sewa of Sri Utkarsh Singh, Addl. Civil Judge (Junior Div.), Mau, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
