

## **Joint Registrar(J)(Budget)**

May kindly see the online application of Sushri Mahima Chaudhary, Additional Civil Judge (Junior Division), Moradabad regarding information about transfer of Chevrolet Spark (Petrol) car from her father's name into her name.

In her application, Sushri Mahima has stated that she has got a Chevrolet Spark car, reg. no. UP15 AH1009 which was registered on her father's name Mr. Narendra Singh to her name. The said vehicle was initially registered on her father's name on 14.08.2008. She has got its registration transferred from her father to her name on 07.02.2020. (Copy of 'Transfer Deed' from the side of her father can be seen as attachment). (Copy of RC of her father as well as transferred RC in the name of the officer can be seen as attachment). The officer has submitted information for kind perusal of Hon'ble Court.

In this connection, it is submitted that the aforementioned car appears to have been purchased by her father. It is further submitted that the relevant Rule 11 of U.P. Government Servant's conduct Rule-1956 relating to gift and, Rule 24 (2) of U.P. Government Servant's conduct Rule-1956 relating to transfer of movable property runs as under: -

*11. Gifts:-A government servant shall not without previous approval of Government :-*

*(a) Accept directly or indirectly on his own behalf or on behalf of any other persons, or*

*(b) Permit any member of his family who is dependent on him, to accept any gift, gratuity or reward from any person other than a close relative.*

*24 (2). "A Government servant who enters into any transaction concerning any movable property exceeding in value, the amount of his basic pay for one month, whether by way of purchase, sale or otherwise, shall forthwith report such transaction to the appropriate authority;*

*Provided that no Government servant shall inter into any such transaction except with or through a reputed dealer or agent of standing, or with the previous sanction of the appropriate authority."*

In view of the above, the information so submitted by the officer is likely to be acceptable, as the car has been gifted by the father of the officer to her daughter, which is the closest blood relative. There appears to be nothing objectionable.

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Attau Rahman Masoodi, Administrative Judge, Moradabad also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for His Lordship's kind perusal and information under Rule 24(2) and Rule (11) of U.P. Government Servant's Conduct Rules, 1956?
