## <u>Joint Registrar (J) (Budget)</u>

May kindly see the online application of Sri Divya Pratap Singh Nimesh, Civil Judge (Jr. Div.)/FTC, Kanpur Nagar by which he has submitted supplementary details/ papers in connection with information about purchase of a new Maruti Baleno car in compliance of Court's order.

In this connection, it is submitted that earlier the officer had informed about purchase of a new Maruti Baleno car on 14.08.2020 for Rs. 7,42,696/-, intimated through application dated 30.12.2020, was submitted before Hon'ble Mr. Justice Virendra Kumar-II, vide office note dated 05.01.2021. Thus, His Lordship has been pleased to order on 04.03.2021 that:-

"The officer Divya Pratap Singh Nimesh, Civil Judge (Jr. Div.)/FTC, Kanpur Nagar has moved application for grant of permission for purchase of Maruti Baleno Delta Petrol Car UP 78 GE 4985 on 14.08.2020 for consideration of Rs. 7,42,696/- from My Car NEXA Pvt. Ltd. Sales, G.T. Road, Kanpur Nagar. The officer joined his services on 16.12.2020.

The section has to report within a month that if the car has been purchased before joining the services, then permission would be required or only information will suffice."

The order was communicated online to the officer.

In reply of the Court's order dtd. 04.03.2021, Sri Divya Pratap Singh Nimesh, has stated that he has written the date of his joining as 16.12.2020 mistakenly and by error in his aforesaid application. This mistake was inadvertent. His actual joining date in Kanpur Nagar Judgeship is 16.12.2019 vide notification no. 4348/Admin. (Services)/2019 dated 13.12.2019 of Hon'ble High Court of Judicature at Allahabad. He has, therefore, requested to consider his application and kindly update the information regarding purchasing of Baleno Delta Petrol Car UP 78 GE4985 in his service record.

Here, it is pertinent to mention that the officer has not submitted for grant of permission to purchase the abovementioned car but has actually submitted information about purchase of car. Moreover, as it was a mistake on the part of the officer regarding his date of joining as 16.12.2019 instead of 16.12.2020. Moreover since the car has been purchased by him after his joining of judicial service, the information as sent by the officer is sufficient.

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Ajai Kumar Srivastava-I for His Lordship's kind perusal & further order in the matter of information about purchase of a new Maruti Baleno car now?
