May kindly see the online application of Sri Madan Mohan, Additional District & Sessions Judge (Fast Track Court), Kushinagar at Padrauna who has joined his service on 04.06.2020, drawing gross salary of Rs. 1,55,957/- & take home salary of Rs. 1,21,948/- regarding information about purchase of a new Mahindra XUV 300 car allotted reg no. UP57AY1314, intimated through application dated 03.01.21.

Through his application, Sri Madan Mohan has submitted information about purchase of a new car 17.09.2020 by giving point wise details as per Court's C.L.no. 25/Admin(A) dated 13.07.1998, according to which the car has been purchased by him from MS Sardar Motors Autowheels Pvt. Ltd. Kasya Road near Reliance Petrol Pump, Ravindra Nagar, Kushinagar who is an authorized dealer, for Rs.12,60,189/- (copy of invoice can be seen as attachment) source of money of which is the bank loan was taken from HDFC Bank Ltd., Padrauna, Kushinagar of Rs. 12,42,189/- repayable in 60 EMIs of Rs. 25,128/- (copy of loan arrangement letter can be seen as attachment) and Rs. 18000/- is stated to have been paid in cash as part payment (copy of receipt can be seen as attachment). It is also pertinent to mention here that the officer has also stated that total amount financed by HDFC bank towards loan is Rs. 12,42,189 /- only out of which an amount of Rs 11,99,250/- only was disbursed by the bank towards purchase price and registration fee of the vehicle and an amount of Rs 18,000/- only was paid by me in cash to the authorised dealer towards the same. Moreover, the Insurance of the vehicle and sarva suraksha plus was also financed by HDFC Bank which is included in the total loan amount of Rs 12,42,189/- only. The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

The matter was previously submitted to Hon'ble Mr. Justice Pradeep Kumar Srivastava, Nominated Judge, through detailed office note dated 12.07.2021, placed above, and after retirement of Hon'ble Nominated Judge, the matter has been reverted back. Thereafter, as per order dated 28.10.2021 of Hon'ble The Chief Justice, such matters i.e. work relating to 'Disposal of the matters of the Judicial Officers, wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956" is assigned to Hon'ble Administrative Judge of the district concerned, where the concerned Judicial Officer is posted. As such, the matter is now likely to be placed before Hon'ble The Administrative Judge of the district concerned.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Pankaj Bhatia, Administrative Judge, Kushi Nagar at Padrauna, also nominated for 'Disposal of the matters of the Judicial Officers, wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956" for the district Kushinagar at Padrauna, for His Lordship's kind perusal and information under Rule 24 (2) U.P. Government Servant's Conduct Rules, 1956?
