May kindly see the online application of Sri Arun Kumar Rana, Additional Civil Judge (Junior Division), Meerut who, joined service on 14.11.2019, drawing gross salary of Rs. 84,188/- & take home salary of Rs. 71,675/- regarding information about purchase of a new Hyundai CRETA 1.5 CRDI MT E, Phantom Black car, allotted reg. no. UP 15 DH1515, intimated through application dtd. 06.01.2021.

Through his application, Sri Arun Kumar Rana has submitted information about purchase of a new Hyundai Creta car on 01.09.2020 by giving point wise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from Mange Ram Enterprises Pvt. Ltd., Loni Road, Shalimar Garden Sahibabad, Ghaziabad who is an authorised dealer, for Rs. 11,24,409/- (copy of invoice can be seen as attachment), source of money of which is that Rs. 9,79,000/- is stated to have been taken as loan from State Bank of India repayable in 84 EMIs of Rs. 15,186/- (copy of loan arrangement letter can be seen as attachment) & rest Rs. 20,000/- & Rs. 1,25,409/- are stated to have been paid through cheque nos. 621444 & 621446 out of his S.B. A/c no. 33336560751 (copy of statement of A/c can be seen as attachment). The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

The matter was previously submitted to Hon'ble Mr. Justice Pradeep Kumar Srivastava, Nominated Judge, through detailed office note dated 26.08.2021, placed above, and after retirement of Hon'ble Nominated Judge, the matter has been reverted back. Thereafter, as per order dated 28.10.2021 of Hon'ble The Chief Justice, such matters i.e. work relating to 'Disposal of the matters of the Judicial Officers, wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956" is assigned to Hon'ble Administrative Judge of the district concerned, where the concerned Judicial Officer is posted. As such, the matter is now likely to be placed before Hon'ble The Administrative Judge of the district concerned.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Meerut, also nominated for 'Disposal of the matters of the Judicial Officers, wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956" for the district Meerut, for His Lordship's kind perusal and information under Rule 24 (2) U.P. Government Servant's Conduct Rules, 1956?
