May kindly see the online application of Sri Vidya Bhushan Pandey, Additional District Judge (FTC), Gonda who joined service on 30.06.2009, drawing gross salary of Rs. 1,70,422/- & take home salary of Rs. 1,30,114/- regarding information about purchase of new Maruti Wagon R Lxi car, intimated through application dated 04.08.2021.

Through his application, Sri Vidya Bhushan Pandey has submitted information about purchase of new car on 30.07.2021 by giving point wise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from Smartwheels Pvt. Ltd., GIDA, Gorakhpur U.P. who is an authorised dealer, for Rs. 6,32,115/- (including accessories & road tax charges) (copy of invoice can be seen as attachment), source of money of which is that Rs. 3,27,000/- is stated to have been adjusted in exchange of his old Maruti Swift Dzire car (copy of purchase receipt can be seen as attachment) & Rs. 2,95,000/- is stated to have been paid to the dealer through RTGS out of his S.B. A/c no. 718110310000025 Bank of India, Gorakhpur (copy of statement of A/c as well as copy of old & new RC can be seen as attachment). The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

It is also submitted that earlier the matter has been submitted before Hon'ble Mr. Justice Ajai Kumar Srivastava-I, Nominated Judge for the purpose vide office note dated 07.10.2021, but the same has been returned due to change of nomination and it is now likely to be submitted before Hon'ble the Administrative Judge concerned as per the order of nomination passed by Hon'ble The Chief Justice vide order dated 28.10.2021.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Gonda, also nominated for "Disposal of the matters of Judicial Officers wherein permission/information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956" for the District Gonda, for His Lordship's kind perusal and information under Rule 24 (2) U.P. Government Servant's Conduct Rules, 1956?
