May kindly see the online application of Sri Dushyant Kumar Sharma, Additional Civil Judge (Junior Division), Moradabad who, joined service on 18.11.2019, drawing gross salary of Rs. 84,488/- & take home salary of Rs. 76,975/- regarding information about purchase of a new Kia Sonet (Diesel) car, allotted reg. no. UP25DB4555, intimated through application dtd. 21.01.2021.

Through his application, Sri Dushyant Kumar Sharma has submitted information about purchase of a new car on 09.12.2020 by giving pointwise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from Ambay Autocars Pvt. Ltd., 5 Kms. Rampur Road, C.B. Ganj, Bareilly who is an authorised dealer, for Rs. 11,25,000/- (copy of invoice can be seen as attachment), source of money of which is that Rs. 8,00,000/- is stated to have been taken as loan from SBI, Moradabad, repayable in 60 EMIs of Rs. 16,031/- (copy of loan arrangement letter can be seen as attachment) & rest Rs. 3,25,000/- is stated to have been paid out of his own S.B. A/c no. 38940389051, SBI, Moradabad (copy of receipt & passbook can be seen as attachment). It is pertinent to mention here that the officer has sold his old Bolero (Diesel) car (Reg. No. UP25 BE 5592) through an authorised dealer, All India Car Dealers association (Regd.) (Membership No. 2000) on 19.10.2020 to Mohd. Shahwaz Islam s/o Hazi Jahoor Islam R/o 786 Chawani Ashraf Khan New Azad Puram, Bareilly. for Rs. 3,75,000/-. The Mode of payment was digital and the entire amount of Rs. 3,75,000 was credited to his S.B. A/c No. 38940389051 in two different installments of Rs. 3,00,000/- on 17.10.2020 and Rs. 75,000/- on 19.10.2020 (copy of exchange document can be seen as attachment). The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

The matter was previously submitted to Hon'ble Mr. Justice Pradeep Kumar Srivastava, Nominated Judge, through detailed office note dated 09.07.2021, placed above, and after retirement of Hon'ble Nominated Judge, the matter has been reverted back. Thereafter, as per order dated 28.10.2021 of Hon'ble The Chief Justice, such matters i.e. work relating to 'Disposal of the matters of the Judicial Officers, wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956" is assigned to Hon'ble Administrative Judge of the district concerned, where the concerned Judicial Officer is posted. As such, the matter is now likely to be placed before Hon'ble The Administrative Judge of the district concerned.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Attau Rahman Masoodi, Administrative Judge, Moradabad, also nominated for 'Disposal of the matters of the Judicial Officers, wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956" for the district Moradabad, for His Lordship's kind perusal and information under Rule 24 (2) U.P. Government Servant's Conduct Rules, 1956?
