May kindly see the online application of Sri Amit Kumar Pande, Special Judge (SC/ST, Pev. of Atroci Act), Faizabad who, joined service on 15.06.2006, drawing gross salary of Rs. 1,63,189/- & take home salary of Rs. 1,23,530/- regarding information about purchase of a new Maruti Suzuki S-Cross car, allotted reg. no. UP32 LU5154, intimated through application dated 04.02.2021.

Through his application, Sri Amit Kumar Pande has submitted information about purchase of a new car on 25.12.2020 by giving point wise details as per Hon'ble Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from KTL Automobile Pvt. Ltd. Cyber Height, Vijayant Khand, Gomti Nagar, Lucknow who is an authorised dealer, for Rs. 10,52,529/- (copy of invoice can be seen as attachment), source of money of which is that Rs. 6,50,000/- has been taken as loan from SBI, Bahraich, repayable in 84 EMIs of Rs. 10083/- (copy of loan arrangement letter can be seen as attachment) Rs. 11,000/- through cheque & Rs. 41,500/- by card are stated to have been paid out of his own S.B. A/c no. 30361954907 (copy of passbook can be seen as attachment). Rs. 3,50,000/- is stated to have been paid as actual exchange value of old car. On this exchange value, exchange bonus of Rs. 20,000/- has been provided by the dealer (copy of payment receipt & exchange declaration can be seen as attachment). The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

The matter was submitted before Hon'ble Mr. Justice Om Prakash-VII, upon which His Lordship has been pleased to order:-

"Office to report as to whether officer has submitted property statement timely or not."

In this connection, it is submitted that the officer has already submitted property statement for the year 2016-20 on 05.11.2020 on Case ID 1756 & property statement for the year 2018-20 on 05.11.2020 on Case ID 1757 on time.

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Salil Kumar Rai, Administrative Judge, Faizabad also nominated for "Disposal of the matters of Judicial Officers, wherein permission /information for sale or purchase of movable/ immovable property and permission/information to accept gift under U.P. Government Servants' Conduct Rules 1956", for His Lordship's kind perusal & further order in the matter of information about purchase of a new Maruti Suzuki S-Cross car?
