May kindly see letter dated 01.02.2021 along with attested copies of mark-sheets(both years) and degree of LL.M (**online attached on 04.03.2021 at SL No. 02**) of Sri Satya Prakash Narayan Tewari, Addl. Civil Judge (Jr. Div.) Gonda, requesting for inclusion of LL.M qualification in his service-records.

Sri Satya Prakash Narayan Tewari, aforesaid, had earlier requested for inclusion of LL.M. Qualification in his service records on 01.02.2021 (**Online**) uploading self attested copies of mark-sheets (both years) and LL.M. Degree (**Online attached on 01.02.2021 at SL No. 01**). Thereafter, he was **asked to submit attested copies (not self attested) of mark-sheets (all semesters/years) as well as LL.M degree through e-ServicesJO portal vide online office note dated 03.03.2021**. Now, he has uploaded relevant LL.M. credentials in this perspective (**online attached on 04.03.2021 at SL No. 02**)

In this context, it is submitted that Sri Satya Prakash Narayan Tewari, aforesaid, joined U.P. Judicial Services on 15.11.2019 as Addl. Civil Judge (Junior Div.), Gonda. Besides, as apparent from submitted attested copies of mark-sheets and degree of LL.M (**online attached on 04.03.2021 at SL No. 02**), Sri Satya Prakash Narayan Tewari, completed LL.M. course in year 2014 and was subsequently awarded Degree from The Global Open University, Nagaland on 09.09.2020. Nevertheless, relevant detail about course completion is not mentioned in his application form of U.P.Nyayik Sewa, thus, said qualification is required to be included in his service records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M degree, may be included in the service records of Sri Satya Prakash Narayan Tewari, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 01.02.2021 of Sri Satya Prakash Narayan Tewari, Addl. Civil Judge (Jr. Div.) Gonda, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may be laid before Hon'ble Mr. Justice Manoj Kumar Gupta, Administrative Judge, Gonda, for kind perusal and if His Lordship approves for order to the effect that copy of aforesaid letter dated 01.02.2021 along with attested copies of mark-sheets and degree of LL.M. (**online attached on 04.03.2021 at SL No. 02**) as well as attested copy of form of U.P. Nyayik Sewa of Sri Satya Prakash Narayan Tewari, Addl. Civil Judge (Jr. Div.) Gonda, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
