May kindly see the online application of Sri Raj Vir Singh, Additional District & Sessions Judge, (POCSO), Kanpur Nagar by which he has submitted supplementary details/ papers in connection with information about purchase of a new Mahindra XUV 500 car in compliance of Court's order.

In this connection, it is submitted that earlier the officer had informed about purchase of a new Mahindra XUV car on 24.07.2020 for Rs. 15,99,518/-, intimated through application dtd. 08.02.2021, was submitted before Hon'ble Mr. Justice Virendra Kumar-II, vide office note dated 09.02.2021. Thus, His Lordship has been pleased to order on 04.03.2021 that:-

“The officer Raj Vir Singh, Special Judge (POCSO)/Additional District & Sessions Judge, Kanpur Nagar joined his services on 06.01.2004. His gross salary is Rs. 1,63,189/- and home take salary is Rs. 1,04,789/-. He has sent information about purchase of a new car Mahindra XUV 500 W7 Model 2020 bearing no. UP 78 GI 1555 from a renowned dealer, namely Sri Tirupati Auto Dealer, the Mall, Kanpur Main Showroom N.H. 2 Sachendi, Kanpur of costs amounting to Rs. 15,99,518/-. He has taken loan amounting to Rs. 10,00,000/- from PNB Kanpur Nagar Civil Lines Branch and he is paying installment amounting to Rs. 15,166/- per month. He has to pay it in 84 installments and Rs. 5,50,000/- is stated to have been paid out of his own S.B. A/c No. 12430004000266376 through NRTGS and Rs. 49,518/- is stated to have been paid in cash out of his household saving.

The officer has to provide within a month information regarding his liability viz., education of children, particulars of his children along with age and household expenses per month. He has to clarify also that what is source of saving specially regarding it from which source, he paid cash amount.”

The order was communicated online to the officer.

In reply of the Court's order dtd. 04.03.2021, Sri Raj Vir Singh, has stated that he has two sons namely Vishal aged 24 yrs, who is a manager in refinery (Indian Oil) Haldiya, West Bengal & Akash aged 22 yrs studying in Lucknow University L.L.B 5th year. The officer has to send him 5000/- Rs. per month. His remaining liability is borne by his elder son Vishal who is still unmarried. Moreover, he has to pay Rs. 35,000/- to Rs. 40,000/- per month to wife for household expenses. Thus, Rs. 49,518/- has been paid in cash which is stated to have been saved by his wife.

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Ajai Kumar Srivastava-I, Nominated Judge for His Lordship's kind perusal & further order in the matter of information about purchase of a new Mahindra XUV 500 car now?
