May kindly see the letter dated 06.02.2021 (uploaded online on 08.02.2021) of Sri Atul Kumar Nayak, Civil Judge (Junior Division), Basti, requesting for inclusion of his LL.M. qualification in his service records vide Case Id No. 02162021 (Old Case Id 1687). In compliance of same Sri Atul Kumar Nayak furnished his LL.M. credentials comprising LL.M. Mark-sheets of both the years and copy of Degree for inclusion of his qualification in his service records.

In this context, it is submitted that, earlier an online inclusion note was submitted before the Hon'ble Mr. Justice Siddharth, the then Administrative Judge, Basti but the note was reverted back to the Section dated 04.08.2021 without any orders due to change in the Administrative Judge. Thereafter, as per new order C.L. No. 15/VIII-C-114 Admin (F) dated 13.07.2021, the note was placed before Hon'ble Mr. Justice Abdul Moin, new Administrative Judge, Basti where His Lordships has been pleased to pass the following order dated 27.08.2021:

## "Let the mark-sheets and degree of LL.M be sent to the concerned University for their verification".

In compliance of the orders of Hon'ble the Administrative Judge, Court's letter no. 11721/IV-4671(Admin A-1) dated 23rd September, 2021 was sent to the Registrar, Swami Vivekanand University, Sagar, Madhay Pradesh to submit the verification report of LL.M. credentials of Sri Atul Kumar Nayak. And, in response of the same, Registrar, Swami Vivekanand University, Sagar, Madhay Pradesh furnished the verification report of LL.M. Mark-sheets (both the years) and Degree of Sri Atul Kumar Nayak vide letter no. F-11/Reg/svnu/2021/veri/ dated 04.11.2021.

In this connection, it is submitted that Sri Atul Kumar Nayak, aforesaid, joined the U.P. Judicial Service on 04.05.2019, as Additional Civil Judge (Junior Division), Basti. Besides, as evident from submitted copies of Mark-sheets (both the years) and Degree of LL.M., Sri Atul Kumar Nayak completed two years LL.M. course, and was subsequently awarded Degree from Swami Vivekanand University, Sagar, M.P. on 04.12.2020 for the examination of April 2014, thus said qualification may be included in his service records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M. Degree may be included in the service records of Sri Atul Kumar Nayak, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 06.02.2021 of Sri Atul Kumar Nayak, Civil Judge (Junior Division), Basti, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may kindly be placed before the Hon'ble Mr. Justice Pankaj Bhatia, Administrative Judge, Basti, for His Lordship's kind perusal and order to the effect that a copy of his application along with copy of mark-sheet (both the years) and degree of LL.M. (uploaded online on 08.02.2021) as well as attested copy of form of U.P. Nyayik Sewa of Atul Kumar Nayak, Civil Judge (Junior Division), Basti, may be sent to the Joint Secretary, Appointment Section – 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter?
