

## **Joint Registrar (Judicial) (Budget)**

May Kindly see the online application of Sri Shivam Verma, Additional Civil Judge (Junior Division), Agra by which he has requested grant of permission to appear in Civil Services Preliminary Examination-2021 conducted by Union Public Service Commission.

In this connection, it is submitted that the officer has stated that he wishes to appear in the Union Public Service Commission Civil Services examination, which is scheduled to be held on 27.06.2021. The matter was submitted Hon'ble Mr. Justice Ved Prakash Vaish but the same got reverted without order due to change of Administrative Judge. Thereafter again the matter was submitted to Hon'ble Mr. Justice Rakesh Srivastava, Administrative Judge, Agra Judgeship, but again that got reverted without order due to change of Administrative Judge. Again the same matter was submitted Hon'ble Mr. Justice Manoj Kumar Gupta, upon which His Lordship has been pleased to pass the following order:

“In the instant matter, Sri Shivam Verma, Addl. Civil Judge (Jr. Div.), Agra has made request for grant for permission to appear in UPSC Examination scheduled to be held on 27.06.2021.

In this regard as desired by Hon'ble Administrative Judge, kindly seek clarification from Officer whether examination is held or yet to be held.”

The order was communicated to the officer through online objection.

In reply the officer has stated that the examination of the preliminary stage is scheduled on 10th October 2021 and Mains examination is proposed for 07th January 2022. Now, It is on the discretion of Hon'ble High Court to accord permission to the officer to appear in the Civil Services Preliminary Examination-2021, conducted by Union Public Service Commission, rescheduled to be held on 10th October 2021. Permission to appear in such type of written examination may be accorded, but subject to the following conditions:-

1. Government work should not suffer in any way.
2. No preferential treatment will be given in the matter of leave, postings and transfer.
3. The permission can be withdrawn without notice if; it is found at any time that the government servant neglects his normal work or that public work suffers, in any way.

May, therefore, if approved by Hon'ble Mr. Justice Manoj Kumar Gupta, Administrative Judge, Agra Judgeship, permission be accorded to Sri Shivam Verma, Additional Civil Judge (Junior Division), Agra to appear in Civil Services Preliminary Examination-2021, conducted by Union Public Service Commission, as requested, subject to the conditions mentioned above?
