May kindly see the online application of Sri Rajesh Parasher, General Manager (Law), U.P. State Industrial Development Corporation, Kanpur Nagar who joined the service 15.06.2006, drawing gross salary of Rs.1,74,038/- & take home salary of Rs.1,28,405/- regarding information about purchase of a new Hyundai Creta Car, allotted reg no. UP15DF8777, intimated through application dated 15.02.21.

Through his application, Sri Rajesh Parasher has submitted information about purchase of a new Hyundai Creta Car 1.5 MpiIVTSX(O) PoLAR WHITE CAR on 05.08.2020 by giving point wise details as per Court's C.L.no. 25/Admin(A) dated 13.07.1998, according to which the car has been purchased by him from Fortune Hyundai (Aspire Automobiles Pvt. Ltd.) Khasra No.571 Bhor crossing Delhi Road, Bulandshahr UP who is an authorized dealer, for Rs. 18,47,848/- (copy of invoice can be seen as attachment) source of money of which is the bank loan was taken from HDFC Bank of Rs. 14 lacs (a/c no.is 111863219) repayable in 84 EMIS of Rs. 21,960/- (copy of loan arrangement letter can be seen as attachment) and Rs. 4,47,848/- has been withdrawn from his S.B.I. salary account no. 30056160477 through cheque no.92915 dated 05.08.2020 (copy of statement of A/c of the officer can be seen as attachment). Moreover the officer was asked to state the reasons that when sale invoice is of Rs. 16,27,113/- then after taking a car loan of Rs. 14,00,000/- a debit entry of Rs. 4,47,848/- is made in favour of M/s Aspire Automobiles Pvt. Ltd, Bulandshahr. Thus, the officer has stated that:-

"The actual cost of Car was Rs. 18,47,848 including taxes. Break-up of amount is below:-

- 1.) Total Price of Car:- Rs. 16,27,113.00
- 2.) Registration fee:- Rs. 1,65,670.00
- 3.) Insurance:- Rs. 47,465.00
- 4.) Accessories:- Rs. 4,000.00
- 5.) Logistics:- Rs. 3,000.00
- 6.) Fast tag:- Rs. 600.00

In this way grand total of price of car is Rs. 18,47,848.00/- including taxes.

Therefore cheque of Rs. 4,47,848.00 was issued by me in favour of Aspire Automobiles Pvt. Ltd. and for payment of remaining amount loan of Rs. 14,00,000.00 is borrowed from HDFC Bank. "

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Anjani Kumar Mishra, Administrative Judge, Kanpur Nagar also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956" for the district Kanpur Nagar, for His Lordship's kind perusal and information under Rule 24 (2) of the U.P. Government Servant's Conduct Rules, 1956?
