

## **Joint Registrar(J)(Budget)**

May kindly see letter dated 20.02.2021 along-with attested copies of mark-sheets (all semesters) and degree of LL.M qualification (**uploaded online on 20.02.2021**) of Sri Hemendra Singh, Civil Judge (Jr. Div.), Bareilly, requesting for inclusion of LL.M qualification in his service-records.

Sri Hemendra Singh, aforesaid, had earlier requested for grant of three advance increments vide letter dated 02.01.2020 bearing endorsement No. 17/7 of District Judge, Bareilly and uploaded self attested copies of mark-sheets and Degree of LL.M. Qualification (**Offline**). Thereafter, he was requested to submit attested (not self attested) copies of mark-sheets (all semesters) and Degree of LL.M. qualification accompanied with prayer for inclusion of LL.M. Qualification in his service-records in online mode only vide office endorsement No. 1044/IV-5018/Admin.(A-1) dated 27.01.2021 (**Offline**). In response, all relevant credentials i.e. attested copies of mark-sheets (all semesters) and Degree of LL.M. Qualification accompanied with prayer for inclusion of LL.M. qualification in his service records has been uploaded (**uploaded online on 20.02.2021**).

In this context, it is submitted that Sri Hemendra Singh, aforesaid, joined U.P. Judicial Services on 15.11.2019 as Addl. Civil Judge (Junior Div.), Bareilly. Besides, as apparent from submitted attested copies of mark-sheets (all semesters) and degree of LL.M. (**uploaded online on 20.02.2021**), Sri Hemendra Singh, completed LL.M. course in year 2019 and was subsequently awarded Degree from Mahatma Jyotiba Phule Rohilkhand University, Bareilly on 02.09.2019. Nevertheless, relevant details about course completion is not mentioned in his application form of U.P. Nyayik Sewa, thus, said qualification is required to be included in his service records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M degree, may be included in the service records of Sri Hemendra Singh, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 20.02.2021 of Sri Hemendra Singh, Civil Judge (Jr. Div.), Bareilly may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may be laid before Hon'ble Mr. Justice Suneet Kumar, Administrative Judge, Bareilly, for kind perusal and if His Lordship approves for order to the effect that copy of aforesaid letter dated 20.02.2021 along with attested copies of mark-sheets (all semesters) and degree of LL.M. (**uploaded online on 20.02.2021**), as well as attested copy of form of U.P.Nyayik Sewa of Sri Hemendra Singh, Civil Judge (Jr. Div.), Bareilly, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
