It is pertinent to mention here that Rs. 2,00,000/- is stated to have been credited to his account through NEFT by his Brother-in-law Dr. Anand Verma through his Salary Account & Rs. 2,00,000/- has been credited to his account through RTGS by his Father through his Business Account (copy of consent letter of his Brother-in-Law as well as Death certificate of his father can be seen as attachment). The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.
