

## **Joint Registrar (J) (Budget)**

May kindly see the online application of Sri Mukesh Kumar Singhal, Presiding Officer, Motor Accident Claim Tribunal, Moradabad regarding information to sell his old Fiat Linea car, intimated through his application dtd. 06.03.2021.

Through his application, Sri Mukesh Kumar Singhal has stated he has sold his old Fiat linea model 2015 car on 16.12.2019 to Smt. Neelam Nautiyal W/o Sri S.N. Nautiyal, R/o 120/4, Nai Basti Chhukhuwala, Dehradun (Uttarakhand) through Dehradun's reputed car dealer M/s. Doon Car Bazar, Dehradun for Rs. 4,70,000/- received through RTGS (copy of certificate of the dealer, delivery receipt, RC as well as his passbook can be seen as attachment). Therefore, he has sold his old car through reputed dealer of Dehradun (Uttarakhand). The purchaser of his old car is not related to him. He has not ever decided any case of the purchaser of his old car. No case of the purchaser of his old car was ever pending before him.

In this connection, it is submitted that the relevant Rule-24 (2) of U.P. Government Servant's conduct Rules, 1956 relating to purchase/sale of movable property are as follows: -

24 (2):- "A Government servant who enters into any transaction concerning any movable property exceeding in value, the amount of his basic pay for one month, whether by way of purchase, sale or otherwise, shall forthwith report such transaction to the appropriate authority;

Provided that no Government servant shall inter into any such transaction except with or through a reputed dealer or agent of standing, or with the previous sanction of the appropriate authority."

The matter was previously submitted to Hon'ble Mr. Justice Pradeep Kumar Srivastava, Nominated Judge, through detailed office note dated 31.08.2021, placed above, and after retirement of Hon'ble Nominated Judge, the matter has been reverted back. Thereafter, as per order dated 28.10.2021 of Hon'ble The Chief Justice, such matters i.e. work relating to 'Disposal of the matters of the Judicial Officers, wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956" is assigned to Hon'ble Administrative Judge of the district concerned, where the concerned Judicial Officer is posted. As such, the matter is now likely to be placed before Hon'ble The Administrative Judge of the district concerned.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Attau Rahman Masoodi, Administrative Judge, Moradabad, also nominated for 'Disposal of the matters of the Judicial Officers, wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956" for the district Moradabad, for His Lordship's kind perusal and information under Rule 24 (2) U.P. Government Servant's Conduct Rules, 1956 for the district Moradabad for His LORDSHIP'S kind perusal and information under rule 24(2) of U.P. Government Servant's Conduct Rules, 1956 ?
