May kindly see the online requisition dated 06.03.2021 of Sushri Priyamvada Priyadarshini, Addl. Civil Judge (Junior Div.), Deoria, requesting for inclusion of her LL.M. qualification in her service records vide Case Id No. 03482021. In view of the above, Sushri Priyamvada Priyadarshini has furnished her duly attested scanned copies of mark-sheet/gradesheet (both semesters) and LL.M. Degree Qualification as well as prayer for inclusion of LL.M. Qualification in her service records. as supporting documents for the same.

In context of the above, it is submitted that Sushri Priyamvada Priyadarshini, aforesaid, joined U.P. Judicial Services on 16.11.2019 as Addl. Civil Judge (Junior Div.), Deoria. Besides, as apparent from submitted attested copies of mark-sheet/gradesheet and degree of LL.M Qualification, Sushri Priyamvada Priyadarshini, completed her one year LL.M. course in the year 2019 and was subsequently awarded Degree from Dr. Ram Manohar Lohia National Law University, Lucknow on 10.07.2019 prior to joining the U.P. Nyayik Sewa, but the said qualification could not be mentioned at the time of filling up the application form, since she was in middle of the course and the result was awaited, as is mentioned in the above noted application. Thus, the said LL.M. qualification is required to be included in her service records.

It is further submitted that the appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M degree, may be included in the service records of Sushri Priyamvada Priyadarshini, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that the aforesaid letter dated 06.03.2021 of Sushri Priyamvada Priyadarshini, Addl. Civil Judge (Junior Div.), Deoria, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may be laid before Hon'ble Mr. Justice Rajnish Kumar, Administrative Judge, Deoria, for his lordship's kind perusal and order to the effect that a copy of her online requisition dated 06.03.2021 along with attested copies of mark-sheet/gradesheet and degree of LL.M. as well as attested copy of form of U.P.Nyayik Sewa of Sushri Priyamvada Priyadarshini, Addl. Civil Judge (Junior Div.), Deoria, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in the instant matter.
